# A BILL INTITULED

AN ACT for the better Securing of Workmen's Wages. BE IT ENACTED by the General Assembly of New Zealand in

Parliament assembled, and by the authority of the same, as follows :----1. The Short Title of this Act is "The Workmen's Wages Act, short Title. -5 1884."

2. In this Act, if not inconsistent with the context,-

"Workman" means and includes any artisan, labourer, or workman engaged on work or labour to be paid for by the day or by the piece.

3. Any workman whose wages for work and labour remain unpaid Workmen suing for twenty-four hours after the time at which they should have been employer may obtain attachment paid may apply to any Justice of the Peace for a summons calling of moneys due to upon the employer of such workman to appear before a Resident employer.

15 Magistrate to answer the demand; and, at the same time or at any time thereafter, any Justice, on being satisfied by the oath of the workman that the sum to be sued for is due by the workman's employer, may grant leave to the workman to serve a notice of attachment of moneys, specifying the sum sued for, upon any 20 employer of such workman's employer.

Such notice shall be in the form or to the effect contained in Form A of the Schedule hereto, and, upon service thereof by personal delivery or by registered letter through the post upon any employer No. 47-1.

of the workman's employer, all moneys in the hands of such lastmentioned persons respectively belonging to or due to the workman's employer, or so much of such moneys as shall be stated in the notice, shall be attached, and shall remain in the hands of the persons holding the same until judgment be given in the case, unless the Resident Magistrate in whose Court the case is to be heard shall otherwise order on the application of any person served with any such notice.

4. No notice of attachment of moneys as aforesaid shall be signed by any Justice of the Peace on behalf of any one workman-

(1.) For any amount exceeding sixty days' wages, no matter what 10 the amount of the demand may be, or whether such demand be in respect of daily, weekly, or monthly wages; nor

(2.) If the work in respect whereof the demand is made appears to have been done upon a movable chattel of such a 15 description that it would be practicable for a workman to have a lien thereon by retaining the same in his possession.

5. The workman, in the event of his obtaining judgment against his employer for the full amount of the wages claimed, or for such 20 of moneys attached. amount less any sum which may be proved to be due by the workman to his employer, and not being forthwith paid, may obtain from the Court, and serve upon the persons upon whom he has previously served any notice of attachment of moneys, an order for the payment of his demand in the Form B in the Schedule hereto or to the 25 effect thereof.

> 6. After service of such order and until a discharge for the workman's demand, in the Form C in the Schedule hereto, is produced, and a copy thereof is left with the person served as aforesaid, such person shall satisfy the workman's demand out of the moneys 30 attached as aforesaid by paying to him, upon his application, the amount of his demand as it becomes due and payable; but no such payment shall be made to any workman under this section by any person served with any order of payment as aforesaid until the expiration of seven days after the service of such order upon him. 35

> 7. All moneys attached as aforesaid shall be paid by the person holding such moneys in priority according to the order of the service of the notices attaching such moneys; but all notices served within seven days of the first of such notices of attachment upon the same person shall be deemed to be served simultaneously, for the purpose 40 of securing the equal distribution of the moneys attached amongst all workmen serving such notices within the aforesaid seven days.

> 8. All demands for wages of workmen who serve simultaneous notices as aforesaid shall rank equally among themselves, and shall be paid in full, subject, however, to the provisions of section thirteen, 45 unless the moneys attached in the hands of any person are insufficient to meet them, in which case they shall abate in equal proportions between themselves.

9. Any person served with an order for payment of moneys under notice liable only for this Act shall not be liable to make good any demand made upon him 50 amount due by him this Act shall not be have to many good any demand to a greater to workman's emextent than the sum which is in his hands due and owing at the time of the service of such notice to the employer of the workman at whose suit the demand is made.

10. If the person served with notice of attachment and order On failure to pay for payment shall fail to pay as aforesaid, the workman may sue for workman may sue and recover in his own name the moneys attached, by any proceeding with notice. which his employer might have taken had there been no attachment

- 5 under this Act, subject to any defence which would have been available against his employer in such proceeding, except a defence founded on the act of the person served with notice of attachment of moneys, after service upon him of such notice.

Upon satisfaction by any other means than as aforesaid of On satisfaction of 10 the whole or any part of the workman's demand mentioned in any demand attachment order for payment under this Act, or on the setting aside of the to operate. judgment in respect of which any such order is given, any attachment of moneys effected under this Act in respect of such demand shall cease to be operative in whole or in part, but without prejudice to any
- 15 bona fide payment or other dealing by the person served with an order for payment in accordance with such order, previous to his receiving notice and sufficient evidence of such satisfaction, or setting aside of judgment.

And so far as may be necessary to such payment or other dealing, 20 the said attachment and order for payment shall continue in force.

12. The workman shall, upon the request of the person paying Workman upon payto him the demand specified in any order for payment under this Act, ment to sign a sign a discharge therefor, in the Form C in the Schedule hereto; and any workman refusing to sign a discharge as aforesaid, if tendered for

25 signature at the time of payment, shall be liable to pay to the person so tendering a sum equal to the amount of the payment, which sum shall be recoverable in a summary way before any one or more Justices of the Peace.

13. Persons furnishing materials to any person for any work to Persons furnishing 30 be done shall be deemed to be workmen within the meaning of this materials for work to have same redress Act, and the persons for whom such materials are furnished shall be as workmen. deemed to be their employers for the purposes of this Act, so far as to enable such first-mentioned persons to avail themselves of the provisions of this Act for the recovery of the debts due to them.

- **3**5 The provisions of this Act shall apply and may be applied Proviso as to accordingly by or in respect to any persons furnishing materials for priority. work, who shall be entitled to priority according to service of notices as hereinbefore mentioned, with the special provision, however, that notices of demands in respect of materials furnished served simulta-
- 40 neously with notices of demands of workmen claiming for work and labour, shall rank equally together, but not until after such lastnamed workmen have been paid not less than the amount of twentyone days' wages in full.

No person for whom any work is being done shall pay any No payment in 45 employer of workmen in advance or beforehand for any such work, advance to be made for work under unless such advance or beforehand-payment is applied towards the construction. payment for material to be used in the work to be done.
