NOTICES RELATING TO ORDERS OF THE DAY.

LOCAL GOVERNMENT.

1. Mr. SEDDON to move, as an amendment to Mr. Montgomery's first Resolution on the subject of Local Government, to omit all the words after "That," and insert the following: "the present central system of government is not so objectionable as the present multifarious systems of local self-government now in force throughout the colony, consisting as they do of Borough Councils, County Councils, Road Boards, Highway Boards, River Boards, Town District Boards, Education Boards, School Boards, Licensing Committees, School Committees, Domain Boards, and others too numerous to mention."

AUCTIONEERS BILL.

2. Mr. SHRIMSKI, in Committee, to move the following amendments:—
 Clause 20, line 25, after "shall," insert, "forthwith pay the net proceeds of such sale, after deducting such auctioneer's expenses and charges of such sale, into some bank in or near to the place where such auctioneer carries on his business, to the credit of a trust account to be opened and kept by such auctioneer in such bank in the name of the Auction Sales Trust Account of [*Here insert name of auctioneer*], and shall".
 Line 28. Strike out the words "do so," and insert in lieu thereof, "render such account, or to open and keep such trust account, or to pay such proceeds or any part thereof into such trust account forthwith after any such sale."

FISHERIES BILL.

3. Mr. CADMAN, in Committee, to move the following new clause:—
 46. For the better preservation of oysters in particular localities, the Governor may from time to time, by Order in Council, transfer to any local authority he shall think expedient the exclusive administration of this Act in relation to oyster-beds and the taking of oysters for sale or export, and may prescribe the manner in which such authority shall exercise the administration; and any such Order in Council may at any time or from time to time be altered or revoked, as the Governor shall think fit.
 For the purposes of this section, and whilst any such exclusive administration as aforesaid is in operation, the words "collector" or "collector at the nearest port," in sections *twenty-eight* to *forty-five*, both inclusive, of this Act shall be taken respectively to mean the local authority appointed to exercise the said exclusive administration, and the said sections shall be construed accordingly.
 In respect of the matters placed under its special administration under this section the local authority—
 (1.) Shall have and may exercise all the powers granted under this Act to a collector, but not those granted to the Commissioner;
 (2.) Shall be entitled to all fees received under this Act within the limits of the special administration, anything to the contrary in section *sixty* contained notwithstanding;
 (3.) Shall not be entitled to any compensation for the loss of the fees aforesaid by reason of the revocation of the special administration.

Clause 3 to be amended by the addition of the words, at the end of the definition of "Fish," "and also includes all shellfish herein not particularly mentioned."

CHATELS SECURITIES BILL.

4. Mr. STEWARD, in Committee, to move the following new clause:—
 It shall not be necessary to file more than one copy of any instrument under Part V. of the said Act, notwithstanding that any such instrument shall or may relate or apply to more than one class of securities.
