NOTICES RELATING TO ORDERS OF THE DAY.

NEGLECTED AND CRIMINAL CHILDREN ACTS AMENDMENT BILL.

Mr. Shephard, in Committee, to move the addition of the following proviso to clause 2:—

Provided always that no child shall be so sent or removed to any school supported for any one or more than one religious denomination, unless such child shall be a member of such denomination, or one of such denominations, if more than one.

Also the addition of the following new clauses:—

- 3. Every order issued under this Act shall be executed and obeyed by the person to whom the same is directed, and shall be sufficient authority to all persons concerned for dealing with the child as therein mentioned.
- 4. Every child removed from one school to another under the provisions of this Act shall be liable to detention in the school to which such child is so removed, for the same period, and be subject to the same liabilities, and be dealt with in the same manner, as if such child had not been so removed as aforesaid.

ANIMALS PROTECTION ACT AMENDMENT BILL.

Hon. Mr. Dick, in Committee, to move the insertion of the following new clause:—

The Colonial Secretary may, in writing, authorize any person or the servants of any such person, at any time, to kill or destroy any animals or birds, whether game or Native game, found on his property and destroying the same, or calculated to become injurious thereto: Provided that the Colonial Secretary shall satisfy himself that such injury is likely to arise through the presence of such animals or birds.

REPRESENTATION BILL.

Mr. Seddon, in Committee, to move the addition of the following new clause:-

From and after the passing of this Act the freehold franchise shall be abolished, and hereafter only persons possessing the residential qualification shall be entitled to vote for the election of members of the House of Representatives, or to become candidates for seats in the said House.

- Mr. Pitr, in Committee, to move the addition of the following new clause:—

 This Act shall, unless previously repealed, come into force on the first day after the close of the next session of the General Assembly.
- Mr. Speight, in Committee, to move the addition of the following new clause:—

 A fresh re-distribution of seats in the House of Representatives shall hereafter take place at the next session of the General Assembly to be holden after each census of the population of the colony shall have been taken, in accordance with the census laws for the time being in force within the colony.

MUNICIPAL CORPORATIONS BILL.

Mr. Swanson, in Committee, to move the addition of the following new clause:—

In respect of any particular trade or trades, for enforcing the closing of all retail establishments in such trade or trades at a certain hour in the evening of each or any working day, whereby the employés in such establishments respectively shall be released from work at an hour not later than the Council shall prescribe.
