CUSTOMS AMENDMENT BILL

Proposed Amendments

Hon. MR ALLEN, in Committee, to move the following amendments:

Clause 2: To omit the word "each" in line 28 on page 2, and substitute the word "the".

Clause 3: To omit from subclause (2) in lines 5 to 7 on page 3 the words "and the New Zealand - Australia Free Trade Agreement Order 1981 are", and substitute the word "is".

To insert, after subclause (2) on page 3, the following subclause:

(2A) The New Zealand - Australia Free Trade Agreement Order 1981 is hereby deemed to have been made under section 125 of the principal Act, and may be amended and revoked accordingly.

Second Schedule: To omit, in relation to Tariff item 21.06.009 on page 26, the third line in the Column headed "Rates of Duty and Exemptions from Duty Substituted", and substitute the following line:

1.1.1985 5

To omit, in relation to Tariff item 74.03.021 on page 39, the third line in the Column headed "Rates of Duty and Exemptions from Duty Substituted", and substitute the following line:

1.7.1986 15

Fourth Schedule: To omit the items relating to reference numbers 10, 15, 25, 26, 55, 95, and 99 on page 48.

EXPLANATORY NOTE

The amendments to *clause 2* and the *Fourth Schedule* omit certain changes to the concessionary duties under Part II of the Customs Tariff.

The amendments to *clause 3* preserve the changes to the Customs Tariff made by the New Zealand - Australia Free Trade Agreement Order 1981, notwithstanding the repeal of the New Zealand - Australia Free Trade Agreement Act 1965.

The amendments to the *Second Schedule* correct clerical errors.
