PROPERTY LAW CONSOLIDATION BILL.

Hon. Mr. TOLE, in Committee, to move the addition of the following clause:—

When a solicitor produces a deed having in the body thereof or endorsed thereupon a receipt for consideration-money, or other consideration, the deed being executed or the endorsed receipt being signed by the person entitled to give a receipt for that consideration, the deed shall be sufficient authority to the person liable to pay or give the same for his paying or giving the same to the solicitor, without the solicitor producing any separate or other direction or authority in that behalf from the person who executed or signed the deed or receipt.

HOSPITALS AND CHARITABLE AID BILL.

Mr. BEETHAM to move, That the Bill be recommitted for the reconsideration of new clause 10A.

To add at the end of the subsection :—

“ Provided that for a period of fifteen years from the first day of January or July next following the entry into occupation of any such endowments, one-third of the proceeds to arise from any such disposition thereof shall be handed over to the County Council or Road Board of the district within which such endowments are situated, to be expended in the construction or maintenance of roads and bridges leading to or opening up such endowments.”

And to add a similar proviso at the end of subsection (5).

The Hon. Mr. STOUT to move, after clause 4, the following :—

4A. For the purposes of this Act all boroughs shall be deemed to be included within the territorial area comprised in the description of the several counties mentioned in the First Schedule, although such boroughs do not actually form part of such counties.

Clause 5. Add the following proviso,—

Provided that for the purposes of the distribution of charitable aid under this Act, the several separate districts hereunder enumerated shall be deemed together to form united districts; that is to say,—

- (1.) The North of Auckland District and the Waikato District with the Auckland District;
- (2.) The Thames District with the Coromandel District;
- (3.) The Waipawa District with the Hawke's Bay District;
- (4.) The Inangahua District and the Nelson Goldfields District with the Nelson District; and
- (5.) The Otago Central District and the Lake District with the Otago District.
