HOSPITAL AND CHARITABLE INSTITUTIONS BILL.

The Hon. Sir J. VOGEL, in Committee, to move,-

To omit the italic proviso, and to substitute the following :----Clause 6.

Provided that in the districts hereinafter mentioned the District Boards shall consist of the persons or local authorities herein also mentioned respectively; that is to say,---

- (1.) Within the Districts of Wairau and Picton, the Chairmen of the Road Boards and the Mayors of the boroughs therein respectively.
- (2.) Within the District of Coromandel, the Council of the County of Coromandel.
- (3.) Within the District of Cook, the Council of the County of Cook and the Borough Council of Gisborne jointly.
- (4.) Within the District of Waipawa, the Council of the County of Waipawa.
- (5.) Within the District of Waitaki, the Council of the County of Waitaki and the Mayors of the boroughs therein.

District of Auckland. Omit the word "Coromandel."

After definition of "District of Auckland" insert-

DISTRICT OF COROMANDEL.

All that area in the colony, being the County of Coromandel, and including all boroughs therein.

Colonel FRASER, in Committee, to move,-

First Schedule.

District of Auckland. Omit the words "Thames, Piako." After the definition "District of Auckland" insert—

DISTRICT OF THAMES.

All that area in the colony, being the Counties of Thames and Piako, and including all boroughs therein.

Mr. LOCKE, in Committee, to move,-

First Schedule.

District of Hawke's Bay. Omit the word "Cook."

After the definition, "District of Hawke's Bay," insert—

DISTRICT OF COOK.

All that area in the colony, being the County of Cook, and including all boroughs therein.

Mr. SMITH, in Committee, to move,-

First Schedule.

District of Hawke's Bay. Omit the words "and Waipawa."

After the definition, "District of Cook," insert-

DISTRICT OF WAIPAWA.

All that area in the colony, being the County of Waipawa, and including all boroughs therein.

District of Otago. Omit the word "Waitaki."

After definition, "District of Otago," insert-

DISTRICT OF WAITAKI.

All that area in the colony being the County of Waitaki, and including all boroughs therein.

District of Otago. Omit the words "Bruce, Tuapeka, and Clutha."

After definition, "District of Central Otago" to insert-

DISTRICT OF TUAPEKA.

All that area in the colony, being the Counties of Bruce, Tuapeka, and Clutha, and including all boroughs therein.

FISHERIES ENCOURAGEMENT BILL.

Sir J. Vogel, in Committee, to move the following new clauses:---

The Governor may, by Order in Council, from time to time prohibit the exportation from the colony of any fish caught or produced in the waters of the colony. Any such order may be made in respect of any particular kind of fish as defined by this Act, or may be made in respect of all fish so defined.

If any fish so prohibited to be exported shall be exported, or found on board of any ship, or be brought to any place to be shipped for exportation from the colony, they shall be forfeited; and any person offending against the provisions of this section, or any Order in Council issued in pursuance thereof, shall, for every such offence, be liable to a penalty of £100, to be recovered in a summary way.

All fish declared liable to forfeiture by this Act may be seized by any officer of Customs in the manner prescribed by "The Customs Laws Consolidation Act, 1882," and may be sold or otherwise disposed of as by that Act is provided in the case of the seizure of uncustomed or prohibited goods.
