# **Supplementary Order Paper**

## Tuesday, 27 April 1993

HEALTH AND DISABILITY SERVICES BILL

Proposed Motion to Divide the Bill into 5 Bills

Right Hon. W. F. BIRCH, in Committee, to move the following motion:

That clauses 1 to 37 and clauses 59 and 61 and the First and Second Schedules be a separate Bill, and that for clause 1 there be substituted the following Title, enacting words, and clause:

An Act to reform the public funding and provision of health services and disability services in order to—

(a) Secure for the people of New Zealand—

(i) The best health; and

- (ii) The best care or support for those in need of services; and
- (iii) The greatest independence for people with disabilities—

that is reasonably achievable within the amount of funding provided; and

- (b) Facilitate access to personal health services and to disability services; and
- (c) Achieve appropriate standards of health services and disability services

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Health and Disability Services Act 1993.
- (2) Except as provided in subsection (3) of this section, this Act shall come into force on the day after the date on which this Act receives the Royal assent.
- (3) Sections 14 to 18 of this Act shall come into force on the 21st day of June 1993.

That Part IV (other than clauses 59 and 61) and the Third to Seventh Schedules be a separate Bill, and that for the heading to Part IV there be substituted the following Title, enacting words, and clause:

An Act to enact provisions that are consequential upon the enactment of the Health and Disability Services Act 1998

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Health Reforms (Transitional Provisions) Act 1993.

- (2) Except as provided in subsections (3) and (4) of this section and in sections 62 (3) and 64 (2) of this Act, this Act shall come into force on the day after the date on which this Act receives the Royal assent.
- (3) Sections 38, 38A, and 47 of this Act shall be deemed to have come into force on the 1st day of April 1993.
- (4) Sections 50 to 58, 62 (1), 63A (3) and (4), 65A (2) and (4), and 66 and 67 of, and the Fourth, Sixth, and Seventh Schedules to, this Act shall come into force on the 1st day of July 1993.

That Part V be a separate Bill, and that for clause 68 and the heading to Part V there be substituted the following Title, enacting words, and clause:

#### An Act to amend the Health Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Health Amendment Act 1993, and shall be read together with and deemed part of the Health Act 1956 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That Part VI be a separate Bill, and that for clause 118 and the heading to Part VI there be substituted the following Title, enacting words, and clause:

#### An Act to amend the Hospitals Act 1957

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Hospitals Amendment Act 1993, and shall be read together with and deemed part of the Hospitals Act 1957 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That Part VII be a separate Bill, and that for clause 150 and the heading to Part VII there be substituted the following Title, enacting words, and clause:

## An Act to amend the Accident Rehabilitation and Compensation Insurance Act 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Accident Rehabilitation and Compensation Insurance Amendment Act (No. 4) 1993, and shall be read together with and deemed part of the Accident Rehabilitation and Compensation Insurance Act 1992 (hereinafter referred to as the principal Act).

(2) Except as provided in subsection (3) of this section, this Act shall come into force on the day after the date on which this

Act receives the Royal assent.

(3) Section 164 (1) of this Act shall come into force on the 1st day of July 1993.
