

SUPPLEMENTARY ORDER PAPER.

HOUSE OF REPRESENTATIVES.

Thursday, the 15th day of July, 1886.

AUCTIONEERS' BILL.

Mr. SEDDON to move, in Committee, the following amendments:—

To strike out all the words after the word "licenses" in the first line of clause 7, and insert the following in lieu thereof:—

Shall be granted and issued by Clerks of Resident Magistrates' Courts to any person who shall deposit with such Clerk the certificate mentioned in the *last-preceding* section on payment into his office of the sum of *forty* pounds.

All sums received as license fees under this Act shall be paid into the Public Account, to a separate account for each provincial district in which such license is issued; and the Colonial Treasurer shall, at least once in each year, divide the total amount received as license fees amongst the local authorities in the said provincial district in which such license was issued, in proportion to the population in each district.

HAWKERS AND PEDLARS' BILL.

Mr. SEDDON to move, in Committee:—

To insert after the word "pedlars," in the first line of clause 8, the word "district"; and in the eighth line of clause 8, after the words "license fees," to insert the words "for district licenses."

New clauses.

1A. Hawkers' general licenses shall be issued only by Clerks of Resident Magistrates' Courts in which the application for the certificate or renewal of certificate was made.

1B. The amounts received for general licenses by the clerks of Resident Magistrates' Courts shall be paid into the Public Account, to a separate account for each provincial district; and the Colonial Treasurer shall, at least once in each year, divide the total amount received for such general licenses in each provincial district amongst the local authorities in the said provincial district in which such license was issued, in proportion to the population in each district.

SALMON AND TROUT ACT 1867 AMENDMENT BILL.

Mr. RED to move, in Committee, the following proviso to section 2:—

Provided that no such nets shall be set within two hundred yards of the mouth of any stream flowing into either of the said lakes, nor shall any such nets be set or used in any of the aforesaid waters between the first day of May and the thirtieth day of September, both inclusive, in each year.

HOSPITALS AND CHARITABLE INSTITUTIONS ACT 1885. AMENDMENT BILL.

Mr. Whyte to move, in Committee,—

That in the fourth paragraph of the First Schedule the word "Piako" be omitted, and that the following paragraph be inserted thereafter:—

All that area of the colony being the County of Piako.

NEW PLYMOUTH HARBOUR LOAN BILL.

Mr. Hislop, in Committee, to move the following amendments:—

Section 7. To strike out all the words after "may," in line 30, and to add the following:—

"Appoint as many polling-places as he may deem necessary for the boroughs and ridings or parts of ridings within the district."

Section 14. After the word "property," in line 8, to insert the following: "in the Borough of Hawera;" and after the word "than," in line 9, to insert "the said Borough of Hawera and."

Schedule. To strike out the First Schedule, and to substitute the following:—

ALL that area described in the Second Schedule to "The New Plymouth Harbour Board Ordinance 1875 Amendment Act, 1877," and also all that area now comprising the Borough of Hawera.
