

SUPPLEMENTARY ORDER PAPER.

HOUSE OF REPRESENTATIVES.

Wednesday, the 4th day of May, 1887.

REPRESENTATION BILL.

1. Mr. COWAN, in Committee, to move, That the blank in subsection (1) of clause 3 be filled in by the word "seventy."
2. Mr. JOHN MCKENZIE, in Committee, to move, That the words "seventy-one" be inserted after the word "be" in the first line of subsection (1), clause 3.
3. Mr. BARRON, in Committee, to move, That the word "sixty," be inserted in subsection (1) of section 3.
4. Mr. CADMAN, in Committee, to move, An addition to subsection (5) of clause 3, whereby the Commission, in forming the new electorates, will be required to combine community of interests as far as practicable.

5. Mr. VINCENT PYKE to move, in Committee, That, in the opinion of this Committee, it is desirable that any Bill providing for the future representation of the people of New Zealand should be based upon a modified form of the electoral system known as the Hare system;

That to this end the large urban and suburban districts should be amalgamated, and that the rural and sparsely-settled districts should also be amalgamated upon a proportionate population basis hereafter to be defined;

And that the Government be requested to remodel the Representation Bill now before the House so as to give effect to the foregoing resolutions.

ELECTORAL ACTS AMENDMENT BILL.

6. Major STEWARD, in Committee, to move the addition of the following new clause:—

(A) The form of claim for enrolment given in the Schedule to this Act shall be substituted for the form given in the Second Schedule to the said Act.

8. Major STEWARD, in Committee, to move the addition of the following new clause:—

12. Nothing in this Act contained shall be deemed to repeal any of the provisions of "The Employment of Females and Others Act 1881 Amendment Act, 1885."
