SALE OF LIQUOR AMENDMENT BILL (NO. 2)

## Proposed Amendments

RUTH RICHARDSON, in Committee, to move the following amendments:

Clause 2: To omit from line 12 on page 2, and also from the heading immediately above the clause (line 8 on that page), the word "wine".

To omit from line 13 on that page the word "wine", and substitute the word "liquor".

To insert in line 17 on that page, before the word "from", the words "every class of liquor specified in the licence,".

To omit from line 22 on that page, and also from line 25 on that page, and also from line 32 on that page, the word "wine".

To omit from line 23 on that page, and also from line 26 on that page, and also from line 27 on that page, the word "wine", and substitute in each case the word "liquor".

Clause 3, proposed section 106A: To omit from line 6 on page 3, and also from the heading immediately above the proposed section (line 4 on that page), the word "wine".

To omit from line 8 on that page, and also from line 9 on page 4, and also from line 24 on that page, the word "wine", and substitute in each case the word "liquor".

To insert in subsection (6) on page 4, after paragraph (a), the following paragraph:

"(b) A statement of the class or classes of liquor in respect of which authority to sell and deliver liquor pursuant to the licence is sought; and

Clause 3, proposed section 106C: To omit from line 4 on page 5 the word "wine".

Clause 3, proposed section 106D: To omit from line 21 on page 5, and also from line 32 on that page, and also from line 35 on that page, and also from line 2 on page 6, and also from line 9 on that page, the word "wine".

To omit from line 41 on page 5, and also from line 5 on page 6, and also from line 6 on that page, the word "wine", and substitute in each case the word "liquor".

Clause 3, proposed section 106E: To omit from line 26 on page 6, and also from line 31 on that page, the word "wine", and substitute in each case the word "liquor".

To omit subsection (6) (all the words in lines 10 to 14 on page 7), and substitute the following subsection:

"(6) The Commission may from time to time, on the application of the holder of any distributor's licence, vary the licence by adding any other class of liquor that may be sold or delivered pursuant to the licence, or by adding or removing the address of any premises from which liquor may be so sold or delivered.

Clause 3, proposed section 106F: To omit from line 17 on page 7 the word "wine".

Clause 4: To omit from line 31 on page 7 the word "wine".

To omit all the words in lines 35 and 36 on that page, and substitute the words "liquor of a class that he is not authorised by his licence to sell or deliver; or".

To omit from line 38 on that page, and also from line 1 on page 8, and also from line 4 on that page, and also from line 6 on that page, the word "wine", and substitute in each case the word "liquor".

To omit from line 9 on page 8 the word "wine".

Clause 4A: To omit from line 22 on page 8 the word "wine", and substitute the word "liquor".

To omit from line 23 on that page the word "wine".

Clause 5: To omit from line 29 on page 8 the word "wine".

Clause 6: To omit from line 33 on page 8 the word "wine".

Clause 7: To omit from line 5 on page 9 the word "Wine".

Clause 8: To omit from line 10 on page 9 the word "wine".

Clause 9: To omit from line 14 on page 9 the word "Wine".

Clause 10: To omit from line 20 on page 9 the word "wine".

To omit from line 22 on that page the word "wine", and substitute the word "liquor".

Clause 11: To omit from line 35 on page 9 the word "wine".

Clause 12: To omit from line 8 on page 10, and also from line 31 on that page, the word "wine".

To omit from line 11 on that page the word "wine", and substitute the word "liquor".

Clause 13: To omit from line 37 on page 10 the word "wine".

Clause 15: To omit from line 12 on page 11 the word "wine".

Clause 16: To omit from line 22 the word "wine".

Title: To omit from line 2 on page 1 the word "wine".

## **EXPLANATORY NOTE**

As the Bill was introduced, the proposed distributor's licence was expressed to apply to all classes of liquor. The Statutes Revision Committee recommended that it be limited to wine. The amendments in this paper would reinstate the original position: that is, the licence would apply to all classes of liquor.
