



**THE ALIENS EMERGENCY REGULATIONS 1940,  
AMENDMENT NO. 3**

**ORDER IN COUNCIL**

At the Government House at Wellington, this 7th day of  
November, 1945

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

**REGULATIONS**

1. These regulations may be cited as the Aliens Emergency Regulations 1940, Amendment No. 3, and shall be read together with and deemed part of the Aliens Emergency Regulations 1940\* (hereinafter referred to as the principal regulations).

2. (1) Regulation 7 of the principal regulations is hereby amended by revoking the definition of the term "alien", and substituting the following definition :—

" 'Alien' means a person of the age of sixteen years or over who is not—

" (a) A British subject ; or

" (b) A woman entitled to the rights, powers, and privileges of a British subject under section 3 of the British Nationality and Status of Aliens (in New Zealand) Amendment Act, 1934-35 : "

(2) Regulation 7 of the principal regulations is hereby further amended by revoking the definitions of the terms " Aliens Authority ", " Appeal Tribunal ", " enemy alien ", " enemy State ", " person of enemy origin or associations ", and " wharf ".

3. (1) The principal regulations are hereby amended by revoking Regulation 18, and substituting the following regulation :—

" 18. Every alien who arrives in New Zealand after the commencement of these regulations shall within seven days thereafter make application for registration as an alien in the manner provided in Regulation 16 hereof, and the provisions of that regulation shall apply accordingly. "

(2) Regulation 19 of the principal regulations is hereby revoked.

(3) Regulation 20 of the principal regulations is hereby amended by omitting the words "or officer of Customs".

(4) Regulation 21 of the principal regulations is hereby amended by revoking clause (2).

(5) Regulation 51 of the principal regulations is hereby amended by omitting the words "officer of Customs".

4. (1) Clause (2) of Regulation 8, and Regulations 10 to 15, 24 to 30, 33, 45 to 49, 55, 56, and 59 of the principal regulations are hereby revoked.

(2) Clause (2) of Regulation 7 of the principal regulations is hereby amended by omitting the words "Subject to a right of appeal to the Aliens Authority for the district", and also by omitting the words "The allowing of any such appeal shall not affect the validity of anything done before the appeal is allowed".

(3) Regulation 3 of the Aliens Emergency Regulations 1940, Amendment No. 1, is hereby revoked.
