THE CUSTOMS AGREEMENT APPLICATION ORDER 1945

ORDER IN COUNCIL

At the Government House at Wellington, this 17th day of
October, 1945

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 3 of the Trade Arrangement (New Zealand and Belgium) Ratification Act, 1933, and to all other powers and authorities enabling him in that behalf, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows :—

1. This Order may be cited as the Customs Agreement Application Order 1945.

2. The following Orders are hereby revoked, namely :—

- (a) The Order in Council made on the 21st day of February, 1934, under the Customs Amendment Act, 1921, and section 3 of the Trade Arrangement (New Zealand and Belgium) Ratification Act, 1933* :

The duties and exemptions from duty provided for by the Trade Arrangement (New Zealand and Belgium) Ratification Act, 1933 (as modified by Orders in Council made on the 3rd day of December, 1934,* and the 28th day of August, 1936†, respectively, and by the Trade Arrangement (Belgium) Order 1938‡), in respect of goods being the produce or manufacture of the Economic Union of Belgium and Luxemburg are hereby applied to similar goods being the produce or manufacture of any of the following countries :—

Argentina.	Czechoslovakia.	Norway.
Brazil.	Egypt.	Spain.
China.	Greece.	Sweden.
