THE EDUCATION AMENDING REGULATIONS 1945 (NO. 2)

C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government House at Wellington, this 31st day of October, 1945

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Education Amending Regulations 1945 (No. 2).

(2) Except as otherwise provided herein, these regulations shall come into force on the day following the date of publication in the Gazette of a notification of the making thereof.

CERTAIN HOME-CRAFT TEACHERS TO CONTRIBUTE TO **TEACHERS'** SUPERANNUATION FUND

2. Clause 3 of the Home-craft Teachers' Certificates Regulations 1943,* is hereby amended by inserting, after subclause (5) thereof, the following additional subclause :-

"(5A) For the purposes of the Public Service Superannuation Act, 1927, any person engaged for not less than twenty hours a week in teaching home-craft in an approved post-primary school or an approved manual and technical class, as part of her training for a certificate under these regulations, shall be deemed to be permanently employed in the Education service. This subclause shall be deemed to have come into force on the 1st day of February, 1945."

Amending Regulations as to Travelling-expenses of Education BOARDS

3. Clause 4 of the Education Boards (Travelling-expenses) Regulations 1944† is hereby amended by omitting the reference to "22s. 6d.", and substituting a reference to "25s.".

AMENDING REGULATIONS AS TO TRAINING COLLEGES

4. Clause 9 of the regulations relating to training colleges (as substituted by clause 5 of the Training College Regulations 1926, Amendment No. 14,* and amended by clause 4 of the Training College Regulations 1926, Amendment No. 18⁺) is hereby further amended by omitting from paragraphs (a) and (b) of subclause (2) thereof the word "October ", and substituting in each case the word "September ".

ADDITIONAL ASSISTANT MASTERS PROVIDED FOR

5. (1) This clause shall be read together with and deemed part of the Teachers' Salaries Regulations 1938[†] (in this clause referred to as the principal regulations).

(2) On the date of the commencement of these regulations, if the Minister so approves, or on any subsequent date approved by him, the numbers of assistant masters allocated under the principal regulations to certain mixed schools, contributing schools, and Native

- (a) In mixed schools and in contributing schools the numbers prescribed in Schedule III of clause 38 and in Schedule VII of clause 54 shall be increased in schools of staffing subgrades VB/C, VC/D, and VIA/B, and all subgrades higher than VIA/B, by the addition of one assistant master with basic salary of Grade B; and, in schools of staffing subgrade VD/A and all higher subgrades, by the addition of one assistant master with basic salary of Grade A.
- (b) In Native schools, the numbers prescribed in Schedule IV of clause 45 shall be increased in schools of staffing subgrade VB/c by the addition of one assistant master with basic salary of Grade B.

Amending Regulations as to Incidental Expenses of School COMMITTEES

6. The regulations relating to the incidental expenses of School Committees (made under the Education Act, 1914, by Order in Council dated the 11th day of October, 1920§), as heretofore from time to time amended, are hereby further amended by adding to the regulation distinguished by the capital letter B the following new paragraph :---

"(i) Half the annual rental charge of a telephone installed in the school."
