

THE EDUCATION (MANUAL-TRAINING TEACHERS) **REGULATIONS 1945**

ORDER IN COUNCIL

At the Government House at Wellington, this 24th day of April, 1945

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

Preliminary

1. (1) These regulations may be cited as the Education (Manualtraining Teachers) Regulations 1945.

(2) Except as provided in Regulation 3 hereof, these regulations shall come into force on the 31st day of March, 1945.

APPLICATION OF THESE REGULATIONS

2. (1) These regulations shall apply with respect to approved manual-training classes established by Education Boards in connection with public schools (including intermediate schools and the secondary departments of district high schools), and to the teachers for the time being engaged in the instruction of such classes.

(2) For the purposes of these regulations the term "approved manual-training class " means a class established for instruction-

- (a) In any subject specified in subclause (3) of clause 15 of the regulations relating to intermediate schools and departments (made under the Education Act, 1914, by Order in Council dated the 15th day of December, 1932)* or in any subject that is for the time being an approved subject within the meaning of that subclause; or
- (b) In any subject for the time being recognized by the Director pursuant to clause 3 of the Manual and Technical Instruction Regulations 1925 (as set out in clause 5 of Amendment No. 14† of those regulations).

INCORPORATION IN THESE REGULATIONS OF THE EDUCATION (POST-PRIMARY TEACHERS) REGULATIONS 1945

3. (1) Subject to the following provisions of these regulations, the provisions of the Education (Post-primary Teachers) Regulations 1945[‡] (including the provisions as to the commencement of those

regulations) shall apply with respect to teachers engaged in the instruction of approved manual-training classes in the same manner and to the same extent as they apply with respect to teachers in schools to which the said regulations apply.

(2) References in the said regulations to schools to which those regulations apply shall, for the purposes of these regulations, be read, where required, as references to approved manual-training classes.

(3) References in the said regulations to the controlling authority of a school shall, for the purposes of these regulations, be read as references to the appropriate Education Board.

(4) Nothing in the said regulations relating expressly to the Principals of schools to which those regulations apply shall be deemed to be applicable for the purposes of these regulations.

(5) Nothing in Part \overline{IV} of the said regulations shall apply with respect to approved manual-training classes.

4. (1) In the application to these regulations of Part II of the said regulations, the reference in Regulation 10 to appeals by post-primary teachers shall be read as a reference to appeals by teachers of approved manual-training classes.

(2) In the application to these regulations of Regulation 22 of the said regulations, the reference in subclause (3) thereof to the certificate of the Principal shall be read as a reference to a certificate to be given by a person authorized in that behalf by the Education Board concerned.

STAFFING OF APPROVED MANUAL-TRAINING CLASSES

5. (1) The number of teachers who may be employed by any Education Board in the instruction of approved manual-training classes shall not exceed such number as may from time to time be fixed or approved in that behalf by the Director.

(2) In determining the number of teachers who may be employed by any Board as aforesaid, the Director may fix or approve the number in respect of all the approved manual-training classes established by the Board, or may fix or approve the number separately in respect of specified classes or in respect of classes established for specified subjects or groups of subjects.

6. $(\hat{1})$ The number of Grade V positions to which manual-training teachers may be appointed in any education district shall be fixed from time to time by the Director :

Provided that the number of Grade V positions in any district shall not at any time exceed one-tenth of the total number, as fixed or approved by the Director in accordance with the last preceding regulation, of manual-training teachers who may be employed by the Education Board of that district.

(2) If one-tenth of the total number referred to in the proviso to the last preceding subclause is not a whole number, the maximum number of Grade V positions shall be the whole number that is nearest to one-tenth of the said total number.
