Pursuant to section 89 of the Fisheries Act 1983 and section 297 of the Fisheries Act 1996, Her Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

Regulations

1 Title

- (1) These regulations are the Fisheries (Central Area Commercial Fishing) Amendment Regulations (No 2) 2001.

- (2) In these regulations, the Fisheries (Central Area Commercial Fishing) Regulations 1986¹ are called “the principal regulations”.

2 Commencement

These regulations come into force on the 28th day after the date of their notification in the *Gazette*.

3 Interpretation

Regulation 2(1) of the principal regulations is amended by adding to the definition of **commercial fisherman** the word “; and” and by adding the following paragraph:

“(c) a commercial fisher”.

4 Netting prohibited in Wellington Harbour

Regulation 9(2) of the principal regulations is amended by—

- (a) omitting the expression “41°17.87’S”, and substituting the expression “41°14.87’S”; and
- (b) omitting each occurrence of the words “Soames Island”, and substituting the words “Matiu/Somes Island”.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

This regulation, which comes into force on the 28th day after the date of its notification in the *Gazette*, amends the definition of **commercial fisherman** to include the words “commercial fisher”, which has been used in amending regulations to reflect a gender-neutral drafting style.

The amendment ensures that, regardless of the terminology used, the regulation applies to those who fish commercially, whether they are

holders of a fishing permit or are fishing under the authority of another person's permit.

The amendments to regulation 9(2) correct an error in 1 of the coordinates defining the area closed to commercial set netters in Wellington Harbour, and also correct the reference to Somes Island to include the Māori name, as confirmed by the Minister of Land Information under section 13 of the New Zealand Geographic Board Act 1946 and notified in the *Gazette* 1997, page 1403.
