THE FRESH-WATER FISHERIES REGULATIONS 1936, AMENDMENT NO. 5

At the Government House at Wellington, this 29th day of August, 1945

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Fresh-water Fisheries Regulations 1936, Amendment No. 5.
- 2. These regulations shall be read together with and form part of the Fresh-water Fisheries Regulations 1936* (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the 2nd day of September, 1945.
- 4. Notwithstanding Regulation 5 of the principal regulations, the principal regulations shall not apply in the Southern Lakes Acclimatization District, except that certain licenses granted under the principal regulations shall be available in part of that district as hereinafter provided.
- 5. (1) Regulation 12 of the principal regulations, as substituted by the Fresh-water Fisheries Regulations 1936, Amendment No. 3, is revoked.
- (2) The reference to Regulation 12 in the Second Schedule to the principal regulations, as substituted by the Fresh-water Fisheries Regulations 1936, Amendment No. 3, shall hereafter be read as a reference to Regulation 6 of these regulations.
- 6. (1) A whole-season license issued in the North Island, except the Rotorua Acclimatization District, shall be available throughout New Zealand, except the Rotorua Acclimatization District and the Southern Lakes Acclimatization District.

(2) A whole-season license issued in any part of the South Island, except the Westland Acclimatization District and the Southern Lakes Acclimatization District, to any person except a man of eighteen years or over shall be available throughout New Zealand, except the Rotorua Acclimatization District and the Southern Lakes Acclimatization District.

(3) A whole-season license issued in the Westland Acclimatization District to any person except a man of eighteen years or over shall be available throughout New Zealand, except the Rotorua Acclimatization District and except that part of the Southern Lakes Acclimatization District which lies outside the Westland Land District.

- (4) A whole-season license issued in any part of the South Island, except the Westland Acclimatization District and the Southern Lakes Acclimatization District, to a man of eighteen years or over shall be available throughout the South Island, except the Southern Lakes Acclimatization District.
- (5) A whole-season license issued in the Westland Acclimatization District to a man of eighteen years or over shall be available throughout the South Island, except that part of the Southern Lakes Acclimatization District which lies outside the Westland Land District.
- (6) A whole-season license issued in any part of the South Island, except the Southern Lakes Acclimatization District, but including the Westland Acclimatization District, to a man of eighteen years or over shall, upon endorsement thereon of a receipt for 5s. signed on behalf of the society of any acclimatization district in the North Island by the secretary or any person authorized to sign licenses issued by that society, be also available throughout the North Island, except the Rotorua Acclimatization District.

(7) The holder of a whole-season license may fish for, take, and kill any species of acclimatized fish in any place where the license is for the time being available during any time between the first and last days (both inclusive) falling within the open season for such

species in the place where the holder is fishing.

7. Regulation 16 of the principal regulations is amended—

(a) By inserting, after the word "license", the words "other than a whole-season license":

(b) By revoking the word "Third".

8. Every whole-season license shall be in the form set out in the Schedule hereto or to the effect thereof.

9. The Third Schedule to the principal regulations is revoked.

SCHEDULE

Whole-season License

License to Fish

[In a license issued in the North Island, except the Rotorua Acclimatization District, insert: every part of New Zealand, except the Rotorua Acclimatization District and the Southern Lakes Acclimatization

[In a license issued in any part of the South Island, except the Westland Acclimatization District and the Southern Lakes Acclimatization District, to any person except a man of eighteen years or over insert: every part of New Zealand except the Rotorua Acclimatization District and the Southern Lakes Acclimatization District.]

[In a license issued in the Westland Acclimatization District to any person except a man of eighteen years or over insert: every part of New Zealand, except the Rotorua District and that part of the Southern Lakes Acclimatization District which lies outside the Westland Land District.]

[In a license issued in any part of the South Island, except the Westland Acclimatization District and the Southern Lakes Acclimatization District, to a man of eighteen years or over insert: every part of the South Island except the Southern Lakes Acclimatization District.]

[In a license issued in the Westland Acclimatization District to a man of eighteen years or over insert: every part of the South Island, except that part of the Southern Lakes Acclimatization District which lies outside the Westland Land District.]

during any portion of the period from the day of, 19.., to the day of, 194. [Insert earliest and latest dates for any part of the Dominion], falling within the open season in the place where the holder is fishing subject to the above-mentioned Acts and to all general and local regulations made thereunder for the time being in force.
