



## Fisheries (Auckland Islands Squid Fishery Prohibition on Trawling for Squid) Notice 2004

Pursuant to section 15(5) of the Fisheries Act 1996, the Minister of Fisheries gives the following notice.

### Notice

- 1 Title**  
 This notice is the Fisheries (Auckland Islands Squid Fishery Prohibition on Trawling for Squid) Notice 2004.
- 2 Commencement**  
 This notice comes into force on 22 March 2004.
- 3 Expiry**  
 This notice expires with the close of 30 September 2004.
- 4 Interpretation**  
 In this notice, unless the context otherwise requires,—  
**Auckland Islands Squid Fishery** means all New Zealand fisheries waters—
  - (a) enclosed by a line commencing at a point 49°30'S and 165°E; then proceeding due east to a point 49°30'S and 168°E; then proceeding due south to a point 51°30'S and 168°E; then proceeding due west to a point 51°30'S

- and 165°E; then proceeding due north to the point of commencement; and
- (b) enclosed by a line commencing at a point 51°30'S and 168°E; then proceeding due east to a point 51°30'S and 171°E; then proceeding due south to a point 53°30'S and 171°E; then proceeding due west to a point 53°30'S and 168°E; then proceeding due north to the point of commencement

**squid** means the fish of which the scientific name is *Nototodarus sloani* or *Nototodarus gouldi*, commonly known as arrow squid.

## **5 Prohibition on trawling for squid**

A person must not fish for squid in the Auckland Islands Squid Fishery by the method of trawling during the period beginning on the commencement of this notice and ending with the close of 30 September 2004.

## **6 Revocations**

The Fisheries (Auckland Islands Squid Fishery—Prohibition on Trawling for Squid) Notice 2002 (SR 2002/95) and the Fisheries (Auckland Islands Squid Fishery Prohibition on Trawling for Squid) Notice 2003 (SR 2003/68) are revoked.
