- Title**  
This order is the Forests (Payment of Money) Order 2004.
- Commencement**  
This order comes into force on the 28th day after the date of its notification in the *Gazette*.

### 3 Payment of money not gross income of recipient

A payment of money made on a date specified in column 1 of the Schedule that is in consideration of the entering into of a conservation covenant over specified Maori land described in column 2 of that schedule is not, in accordance with section 21 of the Forests Amendment Act 2004, gross income of a recipient named in column 3 of that schedule.
