

THE INDUSTRIAL CONCILIATION AND ARBITRATION **AMENDMENT REGULATIONS 1945**

C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington, this 6th day of June, 1945

Present :

THE HON. W. NASH PRESIDING IN COUNCIL

PURSUANT to the Industrial Conciliation and Arbitration Act, 1925, and its amendments, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Industrial Conciliation and Arbitration Amendment Regulations 1945.

(2) These regulations shall be read together with and be deemed to form part of the Industrial Conciliation and Arbitration Regulations 1927–37* (hereinafter referred to as the principal regulations).

(3) The principal regulations, as amended by these regulations, may be cited as the Industrial Conciliation and Arbitration Regulations 1927 - 45.

2. Regulation 15 of the principal regulations is revoked, and the following regulation substituted therefor :--

"15. The certificate required as evidence of compliance with section 35 of the Statutes Amendment Act, 1944, shall be in the form No. 5c, and shall accompany the application (section 35, Statutes Amendment Act, 1944)."

3. The Schedule to the principal regulations is hereby amended as follows :--

(a) By omitting paragraph 5 of the form I.C. 5A, and substituting the following paragraph—

"(5) (Where application is made by a union or association, add) The certificate for reference of the said dispute to a Council of Conciliation for settlement is attached, together with a copy of the rules of the industrial union."

(b) By omitting paragraph 5 of the form I.C. 5B, and substituting the following paragraph—

"(5) (Where application is made by a union or association, add) The certificate(s) for reference of the said dispute to a Council of Conciliation for settlement is (are) attached, together with a copy (copies) of the rules of the industrial union (each of the industrial unions concerned)."

(c) By omitting form I.C. 5c, and substituting the following form-

"[Form I.C. 5c.

"Under the Industrial Conciliation and Arbitration Act, 1925

"CERTIFICATE FOR REFERENCE OF INDUSTRIAL DISPUTE FOR SETTLEMENT "IN the matter of the Industrial Conciliation and Arbitration Act, 1925, and its amendments, and in the matter of the [Insert short descriptive title] dispute, between and

"This is to certify that at a meeting of the Committee of Management of the Industrial Union of held on, the proposed reference of the above-mentioned dispute to a Council of Conciliation for settlement was approved by resolution of the said Committee.
