### Determination

#### 1 Title

- (1) This determination is the Local Government Elected Members (Interim) Amendment Determination 2004.
- (2) In this determination, the Local Government Elected Members (Interim) Determination 2004<sup>1</sup> is called “the principal determination”.

#### 2 Commencement

This determination comes into force for each of the community boards that is listed in the Schedule of this determination on the day on which the result of the 2004 election for that community board is declared under section 86 of the Local Electoral Act 2001.

#### 3 Schedule 2 amended

Schedule 2 of the principal determination is amended by omitting the word “Nil” from the item relating to “Member” for each of the community boards from Schedule 2 that is listed in

the Schedule of this determination, and substituting in each case the amount set out in the Schedule.

### **Explanatory memorandum**

*This memorandum is not part of the determination, but is intended to indicate its general effect.*

This determination makes provision for payment of remuneration to elected members of certain community boards in the interim period between the local elections due to be held in October 2004 and a final determination by the Remuneration Authority.

In those elections, voting will take place for 3 new community boards: Botany Community Board, Coast Community Board, and Whakatane Community Board. There is no provision for members of those boards in this determination. The reason is that the Remuneration Authority has decided that, in respect of those 3 boards, it does not have a basis on which it could appropriately determine a salary for the interim period.
