THE MOTOR-SPIRITS PRICES REGULATIONS 1942, AMENDMENT NO. 1

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 3 of the Motor-spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Motor-spirits Prices Regulations 1942, Amendment No. 1.
- 2. These regulations shall be read together with and form part of the Motor-spirits Prices Regulations 1942* (herein called the principal regulations).
- 3. These regulations shall come into force on the day following notification in the Gazette of the making thereof.
- 4. Regulation 4 of the principal regulations is amended by revoking the definition of "Accredited agent" and by revoking the words "Scale C" in the definition of "Main-port prices".
 - 5. Regulation 7 of the principal regulations is hereby revoked.
- **6.** Regulation 8 of the principal regulations is amended by revoking the words "or an accredited agent".
- 7. Regulation 9 of the principal regulations is hereby amended by revoking all the words following paragraph (b) thereof, and substituting the following words: "then the minimum price and maximum price at which a wholesaler or B depot agent may sell to such person any motor-spirits bought by him during the said part of a year ending on the 31st day of December referred to in paragraph (a) of this regulation shall be the price set out in Regulation 8 hereof".

- 8. Regulation 13 of the principal regulations is hereby amended by revoking the words "Sales Area 3" wherever they occur, and substituting therefor the words "Sales Area 9".
 - 9. The First Schedule to the principal regulations is amended—
 - (a) By deleting the expression "(i)" and the words "(ii) Wholesaler to Agent in Bulk" in Scale A; and
 - (b) By revoking Scale C.
 - 10. The Second Schedule to the principal regulations is amended—
 - (a) By deleting the expression "(i)" and the words "(ii) Whole-saler to Agent in Bulk" in Scale A; and
 - (b) By revoking Scale C.
 - 11. The Third Schedule to the principal regulations is amended—
- (i) By revoking the words "Sales Area 13 (Set of Differentials applicable: No. 11)" and the description of that area following these words and the list of places appended thereto, and by substituting therefor the following:—
 - "SALES AREA 13 (SET OF DIFFERENTIALS APPLICABLE: No. 11)
- "All that area in the North Auckland Land District bounded on the north by Area 10, as described in the Motor-spirits Prices Regulations 1942, notified in the New Zealand Gazette, 1942, on page 1966, from the south-eastern shore of Manukau Harbour to the North Island Main Trunk Railway; thence south-westerly, southerly, easterly, north-easterly, and northerly along the north-western, western, southern, southeenstern, and eastern boundaries of Area 12, as described in the Motor-spirits Prices Regulations aforesaid; thence along a right line to a point 40 chains due north of Paparata Post-office; thence along a right line to a point on the Mangatawhiri-Maramarua Road 40 chains east of Mangatawhiri Post-office; thence due south along a right line to the Maramarua River; thence down the Maramarua River to the Waikato River; thence down the Waikato River to Hood's Landing; thence by a right line to a point 80 chains due west of the Otaua Post-office; thence by a right line to the south-western corner of the Waiuku Town District; thence along the western boundary of the said Town District to the Waiuku River, and down that river to Manakau Harbour; thence along the south-eastern shore of the Manakau Harbour to the westernmost corner of Area 10 aforesaid, the point of commencement.

"Aka Aka.Otaua.Tuakau."Mangatawhiri.Paparata.Waiau Pa."Mercer.Pokeno.Waiuku."

- (ii) By deleting the following words in the description of Sales Area 14: "thence along a right line to the south-western corner of the Town District of Waiuku; thence by the southern boundary of Area 13, hereinbefore described, to the Maramarua River", and by substituting therefor the following words: "thence along a right line to Hood's Landing; thence up the Waikato and Maramarua Rivers, being the southern boundary of Area 13, hereinbefore described, to the south-eastern corner of the said Area 13;".
- (iii) (a) In respect of differentials applicable to Sales Area 28, by revoking the words and figures "Set of Differentials applicable: No. 29", and substituting the following words and figures: "Set of Differentials applicable: No. 27".
- (b) In respect of the differentials applicable to Sales Area 33, by revoking the words and figures "Set of Differentials applicable: No. 25", and substituting the following words and figures: "Set of Differentials applicable: No. 35".
- (c) In respect of the differentials applicable to Sales Area 37, by revoking the words and figures "Set of Differentials applicable: No. 32", and substituting the following words and figures: "Set of Differentials applicable: No. 23".

(d) In respect of differentials applicable to Sales Area No. 38, by revoking the words and figures "Set of Differentials applicable: No. 37", and substituting the following words and figures: "Set of Differentials applicable: No. 27".

(e) In respect of the differentials applicable to Sales Area 39, by revoking the words and figures "Set of Differentials applicable: No. 40", and substituting the following words and figures: "Set of

Differentials applicable: No. 32".

(f) In respect of the differentials applicable to Sales Area 40, by revoking the words and figures "Set of Differentials applicable: No. 42", and substituting the following words and figures: "Set of Differentials applicable: No. 36".

(g) In respect of the differentials applicable to Sales Area 113, by revoking the words and figures "Set of Differentials applicable: No. 122", and substituting the following words and figures: "Set of

Differentials applicable: No. 22".

(iv) (a) By inserting, next following the place-name "Glenbrook", the place-name "Mauka" in the list of places appended to the description of Sales Area 12.

(b) By deleting the place-name "Colyton" from the list of places

appended to the description of Sales Area 68.

(c) By inserting, next following the place-name "Cheltenham", the place-name "Colyton" in the list of places appended to the description of Sales Area 69.

(d) By deleting the place-name "Darfield" from the list of places

appended to the description of Sales Area 87.

(e) By inserting, next following the place-name "Coopers Creek", the place-name "Darfield" in the list of places appended to the description of Sales Area 88.
