**THE POSTAL AMENDING REGULATIONS 1961,
AMENDMENT NO. 2**

THE RIGHT HON. KEITH HOLYOAKE PRESIDING IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Postal Amending Regulations 1961, Amendment No. 2, and shall be read together with and deemed part of the Postal Amending Regulations 1961* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of December 1962.

2. The rates of postage for inland airmail parcels shall be the appropriate rates specified in the Schedule to these regulations.

3. The First Schedule to the principal regulations is hereby amended by omitting from item 10 (under the heading of Inland Parcels) all references to air transport and all references to rates of charges under the heading "By Air Transport".
