PURSUANT to section 57 of the Pharmacy Act 1970, His Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, and on the advice of the Minister of Health, given after consultation by the Minister of Health with the Council of the Pharmaceutical Society of New Zealand, makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Pharmacy Amendment Regulations 1999, and are part of the Pharmacy Regulations 1975* ("the principal regulations").
 - (2) These regulations come into force on 23 December 1999.
- **2. Approved schools**—The principal regulations are amended by revoking regulation 27, and substituting the following regulation:
- "27. The following are approved schools for the purposes of section 13 of the Act:
 - "(a) The Central Institute of Technology:

 - "(c) The University of Otago."
- **3. Prescribed examinations and courses**—The principal regulations are amended by revoking regulation 32, and substituting the following regulation:
- "32. The following examinations and courses of education and training are prescribed for the purposes of section 13 (1) (a) of the Act:
 - "(a) The Diploma in Pharmacy of the Central Institute of Technology:
 - "(b) The Degree of Bachelor of Pharmacy of the University of Auckland:
 - "(c) The Degree of Bachelor of Pharmacy of the University of Otago."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 23 December 1999, amend the Pharmacy Regulations 1975 to add the University of Auckland to the list of approved schools and the Degree of Bachelor of Pharmacy of the University of Auckland to the list of prescribed examinations and courses for the purposes of section 13 of the Pharmacy Act 1970. Section 13 sets out the qualifications a person needs to obtain to be registered as a pharmacist, which include attending an approved school and passing its examinations.
