



**THE PAPER (MANUFACTURE AND SALE) CONTROL
NOTICE 1942, AMENDMENT NO. 1**

PURSUANT to the Factory Emergency Regulations 1939,* I, George Augustus Pascoe, Factory Controller, hereby direct and give notice as follows :—

1. This notice may be cited as the Paper (Manufacture and Sale) Control Notice 1942, Amendment No. 1, and shall be read together with and deemed part of the Paper (Manufacture and Sale) Control Notice 1942† (hereinafter referred to as the principal notice).

2. This notice shall come into force on the day next following the date of notification hereof in the *Gazette*‡.

3. Clause 7 (b) of the principal notice is hereby amended by omitting the words “ subclause (i) of ”.

4. Clause 9 of the principal notice is hereby amended by adding the following subclause :—

“(c) For the purposes of this clause the expression ‘ specially-printed matter ’ does not include any catalogue or any pamphlet, circular, leaflet, folder, book, or booklet of a kind referred to in clause 11 hereof.”

5. The principal notice is hereby amended by revoking clauses 11 and 12, and substituting the following clauses :—

“ 11. Except with the prior consent in writing of the Factory Controller, no person shall commence the printing of any catalogue or of any pamphlet, circular, leaflet, folder, book, or booklet which principally contains advertising-matter, or publicity or propaganda of any description whatsoever.

“ 12. In any case where the Factory Controller gives a consent under clause 11 hereof he shall assign a number to the consent issued by him, and the person who pursuant to the consent prints any catalogue, pamphlet, circular, leaflet, folder, book, or booklet shall print therein or thereon in a prominent position the number of the consent.”

6. Clause 13 of the principal notice is hereby amended by revoking paragraph (f) thereof.

7. Clause 13 of the principal notice is hereby further amended by omitting from paragraph (l) the words “ (including one-sided blotters bearing advertising-matter on the reverse) ”.

8. Clause 14 of the principal notice is hereby amended as follows :—

(a) By omitting from subclause (a) the words “ within thirty days of the coming into force of this notice ”, and substituting the words “ before the 30th day of November, 1942 ” :

(b) By omitting from subclause (a) the word “ quantity ” wherever that word occurs, and substituting in each place the words “ area and weight ” :

(c) By omitting from subclause (b) the words “ the expiration of thirty days from the coming into force of this notice ”, and substituting the words “ the 30th day of November, 1942 ”.

9. Clause 17 of the principal notice is hereby amended by adding thereto the following :—

10. The principal notice is hereby further amended by adding thereto the following additional clauses :—

“ 18. On and after the 30th day of November, 1942, no user of, or other person owning, any article referred to in clause 13 or clause 16 hereof of a size in excess of the maximum size prescribed therein in respect of articles of that kind shall use that article or permit that article to be used until it has been reduced to a size not exceeding the maximum size so prescribed :

“ Provided that nothing in this clause shall apply—

“ (a) To bound forms ; or

“ (b) Where cutting to the reduced size would destroy the utility of the article for the purpose for which it is intended ; or

“ (c) Where the offcut would be entirely useless for any other purpose.

“ 19. (a) In any case where it is necessary in the production of any of the articles referred to in clause 13 or clause 16 of this notice to cut sheets of paper, the articles shall be of such size that the whole of each sheet is used without waste or offcut.

“ (b) In any case where compliance with the provisions of subclause (a) of this clause necessitates a modification in the size of the article, the modified size shall be smaller than the size of any similar article previously produced for the same purchaser.

“ 20. No person shall acquire any article of manufactured stationery (having a paper content but not being specially-printed matter within the meaning of clause 9 of this notice) in a quantity which, when added to stocks on hand and supplies from any other source, will bring the total supplies in the possession of the person acquiring the article, being supplies of that article and of any other article capable of being used as a substitute therefor, to an aggregate quantity in excess of what is required for three months' use.

“ 21. Notwithstanding anything contained in the foregoing provisions of this notice, except with the prior consent in writing of the Factory Controller, no person shall manufacture any school paper stationery coming within the scope of the New Zealand Standard Specification for School Paper Stationery (N.Z.S.S. 362)* unless it complies with the provisions of that specification, including any amendment that may hereafter be made :

“ Provided that in the case of writing-pads the paper shall not exceed in weight the equivalent of 18 lb. per 500 sheets of a size 16½ in. by 21 in. and shall not be less than the equivalent of 15 lb. per 500 sheets of the same size.”
