**THE POST AND TELEGRAPH OFFICERS' SICK BENEFIT
FUND REGULATIONS 1951, AMENDMENT NO. 1**

ORDER IN COUNCIL

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Post and Telegraph Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Post and Telegraph Officers' Sick Benefit Fund Regulations 1951, Amendment No. 1, and shall be read together with and deemed part of the Post and Telegraph Officers' Sick Benefit Fund Regulations 1951* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of January 1954.

2. (1) Regulation 2 of the principal regulations is hereby amended as follows:

(a) By omitting the definition of the term "the said section", and substituting the following definition:

"The said section means section 243A of the Post and Telegraph Act 1928 (as inserted by section 5 of the Post and Telegraph Amendment Act 1953)";

(b) By inserting, after the definition of the term "dependant", the following definition:

"'Employee' means a person referred to in subsection (4) of the said section";

(c) By omitting the definition of the term "officer".

(2) The principal regulations are hereby amended by omitting the word "officer" wherever it occurs, and substituting in every case the word "employee", and by omitting the word "officers" wherever it occurs, otherwise than in regulation 1 thereof, and substituting in every case the word "employees".

3. (1) Subject to the provisions of this regulation, any person employed temporarily in the Post and Telegraph Department may, by written application to the trustees, apply to become a contributor to the fund.

(2) No person employed temporarily in the Post and Telegraph Department may apply to become a contributor to the fund unless he has had a total of at least five years' service with that Department.

(3) Any person who becomes a contributor to the fund under this regulation shall do so on such terms and conditions as the trustees may determine, and any such person who has been accepted by the trustees as a contributor shall be deemed to be an employee to which the said section applies.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

The purpose of these regulations is to enable temporary employees of the Post and Telegraph Department to become contributors to the Post and Telegraph sick benefit fund.
