**THE POST AND TELEGRAPH (STAFF) REGULATIONS 1925,
AMENDMENT NO. 14.**

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 18th day of
October, 1939.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Post and Telegraph Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Post and Telegraph (Staff) Regulations 1925, Amendment No. 14.

2. These regulations shall be read together with and form part of the regulations made under the Post and Telegraph Department Act, 1918, on the 14th day of December, 1925* (hereinafter called the principal regulations), as heretofore amended from time to time.

3. These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.†

4. Clause (1) of Regulation 69 of the principal regulations is amended by revoking the words—

“(b) In excess of forty hours weekly from Monday to Saturday inclusive”

and substituting the following words :—

“(b) In the case of tradesmen employed in departmental workshops and other officers and temporary employees employed on the line staff, with the exception of those designated faultmen, in excess of forty hours weekly from Monday to Friday inclusive, or at any time on Saturday or Sunday ;

“(bb) In the case of any person not comprised in paragraph (b) of this clause, in excess of forty hours weekly from Monday to Saturday inclusive.”

5. Clause (6) of Regulation 69 of the principal regulations is amended by revoking the words—

“(d) On other occasions as may be decided from time to time by the Permanent Head”

and substituting the following words :—

“(d) By tradesmen employed in departmental workshops and other officers and temporary employees employed on the line staff, with the exception of those designated faultmen—

“(i) In excess of eight hours on any one day ;

“(ii) In excess of forty hours from Monday to Friday inclusive, in any week ;

“(iii) In excess of four hours before noon on any Saturday ;

“(iv) For any period after noon on any Saturday ;

“(e) By any person in the Second Division not comprised in paragraph (d) of this clause, after forty-four hours have already been served in the same week ;

“(f) By any person in the Second Division not comprised in paragraph (d) of this clause, on being recalled to duty on any day after having performed his normal hours of duty for the day and having left the place of employment ;

“(g) On other occasions as may be decided from time to time by the Permanent Head.”
