THE POST AND TELEGRAPH (STAFF) REGULATIONS 1925, AMENDMENT NO. 17

At the Government House at Wellington, this 26th day of November, 1943

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post and Telegraph Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1 These regulations may be cited as the Post and Telegraph (Staff) Regulations 1925, Amendment No. 17.
- 2. These regulations shall be read together with and form part of the regulations made under the Post and Telegraph Department Act, 1918, on the 14th day of December, 1925, as heretofore amended.
- 3. These regulations shall come into force on the 29th day of November, 1943.
- 4. Clauses (1) and (2) of Regulation 69 of the principal regulations as heretofore amended are revoked, and the following substituted:—
- "69. (1) In these regulations "overtime" means the time in which any official or departmental duty is performed—"(a) On Sunday; or

- "(b) On the departmental holidays specifically named in Regulation 81 or substituted by Order in Council as mentioned in Regulation 81; or
- "(c) In the case of any person not comprised in paragraph (d) of this clause, as described in paragraphs (a) and (b) of this clause or in excess of forty hours weekly from Monday to Saturday inclusive; or
- "(d) By tradesmen employed in departmental workshops and other officers and temporary employees employed on the line staff, with the exception of those designated faultmen-
 - "(i) As described in paragraphs (a) and (b) of this clause; or
 - "(ii) In excess of eight hours on any one day; or
 - "(iii) In excess of forty hours from Monday to Friday inclusive; or
 - "(iv) At any time on Saturday;

- "(e) In the case of all officers and temporary employees, after 10 p.m. when the officer or temporary employee is required to resume duty next day before 6 a.m.; or
- "(f) In any other case as may be decided from time to time by the Permanent Head.
- "(2) (a) Except for duty performed—

" (i) On Sunday;

- "(ii) On the departmental holidays specifically named in Regulation 81 or substituted by Order in Council as mentioned in Regulation 81;
- "(iii) On such other occasions as may be decided from time to time by the Permanent Head,—

the rate of overtime shall be at a rate equal to one and a half times the hourly rate of pay of the officer or temporary employee concerned:

- "Provided that the minimum rate shall be 2s. 3d. an hour and the maximum rate 6s. 9d. an hour, save that in the case of junior assistants the rate shall be not less than 1s. 6d. an hour.
 - "(b) For duty performed—

"(i) On Sunday;

- "(ii) On the departmental holidays specifically named in Regulation 81 or substituted by Order in Council as mentioned in Regulation 81;
- "(iii) On such other occasions as may be decided from time to time by the Permanent Head,—

the rate of overtime shall be at a rate equal to double the hourly rate

of pay of the officer or temporary employee concerned:

- "Provided that the minimum rate shall be 3s. an hour and the maximum rate 6s. 9d. an hour, save that in the case of junior assistants the rate shall be not less than 2s. an hour."
- 5. Clauses (6) and (6A) of Regulation 69 of the principal regulations, as heretofore enacted, are revoked.
