THE POST AND TELEGRAPH STUDENTSHIP REGULATIONS 1939.

GALWAY, Governor-General.
ORDER IN COUNCIL.

At the Government House at Wellington, this 15th day of November, 1939.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Post and Telegraph Act, 1928, and to all other powers enabling him in this behalf, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Post and Telegraph Studentship Regulations 1939.
- 2. Studentships are offered to enable the holders thereof to undertake specialized study in radio-physics, subject to the provisions hereinafter contained.
- 3. Applications for studentships must be made in writing signed by the applicant and delivered to the Director-General of the Post and Telegraph Department at Wellington not later than the 20th day of November in the year preceding that in which the specialized study is proposed to be undertaken:

Provided that on the advice of the Radio Development Advisory Committee set up by the Postmaster-General (hereinafter called the Committee) the Director-General may accept an application received later than the date aforesaid.

4. Every application shall be supported by certificates signed by a Professor of the University of New Zealand and by some other suitable person to the effect that in the opinion of the person giving the certificate the applicant is a fit and proper person to be awarded a studentship under these regulations.

- 5. Preference in awarding studentships will be given (subject to satisfactory general qualification) to persons who are graduates of the University of New Zealand and have passed the examinations termed Physics III and Pure Mathematics II as defined by the said University as subjects of examination for the degrees of Bachelor of Arts and Bachelor of Science, and to persons who have passed equivalent examinations.
- 6. Nevertheless, should insufficient persons considered suitable for awards be qualified as set out in the last preceding clause, consideration may be given to applicants who have passed six units of examination for the degree of Bachelor of Science and to persons who have passed equivalent examinations.
- 7. Every award of a studentship shall be made by the Director-General of the Post and Telegraph Department on the advice of the Committee.
- 8. Each studentship shall be tenable for one year (subject to termination as hereinafter provided), and shall be of a value of not less than £155 or more than £255, to be fixed by the Director-General according to the qualifications of the student as estimated by the Director-General, and to be payable by such instalments as the Director-General may from time to time decide.
- **9.** Forthwith after the end of every academic term every student shall furnish to the Director-General for consideration by the committee a report from a Professor of the University as to the progress of his studies, and any instalment of the studentship may be withheld pending receipt of such report or on receipt of a report indicating unsatisfactory progress.
- 10. A studentship may at any time be determined if the Committee is not satisfied that the holder has complied and is complying with the terms on which the same has been awarded and the conditions imposed by the Committee as hereinafter mentioned, or that the holder is devoting himself with assiduity and success to specialized study as hereby required.
- 11. Every student shall during the year of his studentship carry out a course of specialized study in radio-physics at Canterbury University College or Auckland University College as the Committee may decide and in accordance with such conditions as the Committee may impose and the Director-General notify to the student.
- 12. Except in special cases and with the consent of the Committee given through the Director-General, no student shall during his studentship engage in any work or occupation not associated with the course of study for which the studentship was granted or not in accordance with the conditions relating to his study imposed by the Committee.
- 13. Except with the consent of the Committee given through the Director-General, no student shall at any time publish or communicate for publication any report or information as to the nature, progress, or results of any investigation carried out by him in the course of his studies.
- 14. No studentship shall be held in conjunction with a University or other scholarship if the annual amount thereof combined with the studentship exceeds £320.

15. Immediately on the termination of his studentship every student shall offer his services to His Majesty's Government in some service thereof to be approved by the Director-General on the terms of employment usual in such branch or with some institution approved by the Director-General, and will not terminate or seek to terminate such employment for three years immediately following the year of his studentship.
