THE POST AND TELEGRAPH STAFF REGULATIONS 1951,

ORDER IN COUNCIL

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Post and Telegraph Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Post and Telegraph Staff Regulations 1951, Amendment No. 4, and shall be read together with and deemed part of the Post and Telegraph Staff Regulations 1951\* (hereinafter referred to as the principal regulations).

2. These regulations shall be deemed to have come into force on the 15th day of September, 1953.

3. (1) Subject to the provisions of this regulation, the remuneration of employees of the Department shall be increased by an amount equal to 10 per cent thereof.

(2) There shall be excluded from the scope of this regulation such portion of the employees' remuneration in each week as exceeds the amount of £12 in the case of adult male employees, the amount of £9 in the case of adult women employees, and the amount of £7 in the case of junior workers.

(3) For the purposes of this regulation the term "remuneration" includes all salary, wages, and allowances payable under the principal regulations except allowances payable in respect of tools, bicycles, motor vehicles, protective or special clothing, or boots.

(4) For the purposes of this regulation a male employee who is entitled to be paid the minimum remuneration prescribed for male married employees shall be deemed to be an adult male employee.

(5) For the purposes of this regulation an employee of either sex who is under the age of twenty-one years shall, except as otherwise provided by subclause (4) hereof, be deemed to be a junior worker.
