**THE PROFESSIONAL CHARGES (PRICE FREEZE)
REGULATIONS 1976, AMENDMENT NO. 1**

ORDER IN COUNCIL

At the Government House at Wellington this 30th day of August 1976

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title, commencement, and expiration—(1) These regulations may be cited as the Professional Charges (Price Freeze) Regulations 1976, Amendment No. 1, and shall be read together with and deemed part of the Professional Charges (Price Freeze) Regulations 1976* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

(3) These regulations shall continue in force until the expiration of the principal regulations.

2. Charges by veterinary clubs to members excluded—(1) The principal regulations are hereby amended by inserting, after regulation 12, the following regulation:

“13. Nothing in these regulations shall apply in respect of charges made by any veterinary club for veterinary services performed by it or on its behalf for its members.”

(2) Regulation 11 of the principal regulations is hereby amended by inserting, after the word “charges” the words “(other than charges of the kind described in regulation 13 of these regulations)”.

3. Schedule to principal regulations amended—(1) The Schedule to the principal regulations is hereby amended by revoking clause 1, and substituting the following clause:

“1. Services (whether as accountants, auditors, consultants, advocates, investigators, or advisers) performed by chartered accountants or chartered accountants in public practice within the meaning of the New Zealand Society of Accountants Act 1958.”

(2) The Schedule to the principal regulations is hereby further amended by revoking clause 6.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Professional Charges (Price Freeze) Regulations 1976.

Regulation 2 exempts from the provisions of the principal regulations, charges made by any veterinary club for veterinary services performed by it or on its behalf for its members.

Regulation 3: Subclause (1) extends the range of services performed by accountants which are within the provisions of the principal regulations.

Subclause (2) exempts services performed by dental technicians from the provisions of the principal regulations.
