

# THE PERIODIC DETENTION CENTRES (INVERCARGILL AND RICHMOND) NOTICE 1995

PURSUANT to section 126 of the Criminal Justice Act 1985 (as substituted by section 47(1) of the Criminal Justice Amendment Act 1993), the Minister of Justice hereby gives the following notice.

#### NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Periodic Detention Centres (Invercargill and Richmond) Notice 1995.
  - (2) This notice shall take effect from the 26th day of October 1995.
- 2. Invercargill Periodic Detention Centre—The land described in the First Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Invercargill Periodic Detention Centre.
- **3. Richmond Periodic Detention Centre**—The land described in the Second Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Richmond Periodic Detention Centre.
- 4. Amendment—The Work Centres Notice 1987\* is hereby amended—
  - (a) By revoking clause 3; and
  - (b) By revoking the Second Schedule.

#### SCHEDULES

## FIRST SCHEDULE

INVERCARGILL PERIODIC DETENTION CENTRE

All that parcel of land in the Southland Land District containing 1518 square metres, more or less, being Lot 1 on Deposited Plan 12121 and being part Section 11 Block LXIX, Town of Invercargill, and being all the land comprised and described in certificate of title, No. 9A/370, Southland Registry.

## SECOND SCHEDULE

## RICHMOND PERIODIC DETENTION CENTRE

All that area shown on the plan marked LRD 28-6, held in the Head Office of the Ministry of Justice, and thereon marked red; being part of that piece of land in the Waimea Survey District containing 1 rood 38.7 perches, more or less, being part Section 82, Waimea East, being Lots 1 and 2 on Deposited Plan 4926, and being part of the land comprised and described in certificate of title, Volume 8, folio 41, Nelson Registry.

#### **EXPLANATORY NOTE**

This note is not part of the notice, but is intended to indicate its general effect.

This notice, made pursuant to the Criminal Justice Act 1985,—

(a) Declares the land described in the First Schedule to the notice to be a periodic detention centre, to be known as the Invercargill Periodic Detention Centre; and

(b) Declares the land described in the Second Schedule to the notice to be a periodic detention centre, to be known as the Richmond Periodic Detention Centre. The new Invercargill Periodic Detention Centre replaces the Esk Street Work Centre.
