

THE PERIODIC DETENTION CENTRES (TAKAPUNA AND SILVERDALE) NOTICE 1993

PURSUANT to section 126 of the Criminal Justice Act 1985 (as substituted by section 47 (1) of the Criminal Justice Amendment Act 1993), the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Periodic Detention Centres (Takapuna and Silverdale) Notice 1993.
 - (2) This notice shall take effect from the 17th day of January 1994.
- 2. Takapuna Periodic Detention Centre—The land described in the First Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Takapuna Periodic Detention Centre.
- **3. Silverdale Periodic Detention Centre**—The land described in the Second Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Silverdale Periodic Detention Centre.
- 4. Amendments—(1) The Work Centres Notice (No. 2) 1984* is hereby amended—
 - (a) By revoking subclause (5) of clause 2; and
 - (b) By revoking so much of the Schedule as relates to the land described as the Hinemoa Street Work Centre.
 - (2) The Reporting Centres Notice 1986† is hereby amended—
 - (a) By revoking subclause (3) of clause 2; and
 - (b) By revoking the Third Schedule.

FIRST SCHEDULE

Cl. 2 TAKAPUNA PERIODIC DETENTION CENTRE

All that parcel of land in the North Auckland Land District containing 3 roods 22.9 perches, more or less, situated in the City of Takapuna, and being Lot 1, Deposited Plan 68121, and being part Allotments 104A and 190, Parish of Takapuna, and being all the land comprised and described in certificate of title, No. 23C/592, North Auckland Land Registry.

SECOND SCHEDULE

Cl. 3 SILVERDALE PERIODIC DETENTION CENTRE

First, all that parcel of land in the North Auckland Land District, containing 895 square metres, more or less, being Lot 3 on Deposited Plan 40992, and being part Allotment 20, Parish of Okura, and being the whole of the land comprised and described in certificate of title, Volume 5D, folio 178, North Auckland Registry; and

Secondly, all that parcel of land in the North Auckland Land District, containing 809 square metres, more or less, being Lot 4 on Deposited Plan 40992, and being part Allotment 20, Parish of Okura, and being the whole of the land comprised and described in certificate of title, Volume 3D, folio 1313, North Auckland Registry.
