# THE PERIODIC DETENTION CENTRES (TIMARU AND TEMUKA) NOTICE 1996

PURSUANT to section 126 of the Criminal Justice Act 1985, the Minister of Corrections hereby gives the following notice.

# NOTICE

1. Title and commencement—(1) This notice may be cited as the Periodic Detention Centres (Timaru and Temuka) Notice 1996.

(2) This notice shall take effect from the 13th day of June 1996.

**2. Timaru Periodic Detention Centre**—The land described in the First Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Timaru Periodic Detention Centre.

**3. Temuka Periodic Detention Centre**—The land described in the Second Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Temuka Periodic Detention Centre.

4. Amendments—(1) The Work Centres Notice (No. 3) 1984\* is hereby amended—

(a) By revoking subclause (1) of clause 2; and

- (b) By revoking so much of the Schedule as relates to the land described as the High Street Work Centre.
- (2) The Reporting Centres Notice (No. 2) 1989<sup>+</sup> is hereby amended—
- (a) By revoking subclause (1) of clause 2; and
- (b) By revoking the First Schedule.

5. Revocation—The Reporting Centre (Waimate) Notice 1993‡ is hereby revoked.

## SECOND SCHEDULE

#### TEMUKA PERIODIC DETENTION CENTRE

All that parcel of land in the Canterbury Land District containing 31.55 perches, more or less, situated in the Borough of Temuka (Canterbury R.D.) (S.O. Plan 8046), being Reserve 4559, and formerly part Reserve 283; as the same is notified in *Gazette*, 1950, page 102, as Crown Land set apart for Police purposes in the Borough of Temuka.

#### EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, made pursuant to the Criminal Justice Act 1985,-

(a) Declares the land described in the First Schedule to the notice to be a periodic detention centre, to be known as the Timaru Periodic Detention Centre; and

(b) Declares the land described in the Second Schedule to the notice to be a periodic detention centre, to be known as the Temuka Periodic Detention Centre.

The new Timaru Periodic Detention Centre replaces the High Street Work Centre.

The Temuka Periodic Detention Centre is the same centre previously known as a reporting centre for the High Street Work Centre and deemed to be a periodic detention centre by section 47 (6) of the Criminal Justice Amendment Act 1993.

This notice revokes the notice that established a reporting centre at Waimate for the High Street Work Centre, as this centre is no longer operational.
