

# THE PERIODIC DETENTION CENTRES (HASTINGS AND WAIPUKURAU) NOTICE 1994

PURSUANT to section 126 of the Criminal Justice Act 1985 (as substituted by section 47 (1) of the Criminal Justice Amendment Act 1993), the Minister of Justice hereby gives the following notice.

### NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Periodic Detention Centres (Hastings and Waipukurau) Notice 1994.
  - (2) This notice shall take effect from the 15th day of May 1994.
- 2. Hastings Periodic Detention Centre—The land described in the First Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Hastings Periodic Detention Centre.
- **3. Waipukurau Periodic Detention Centre**—The land described in the Second Schedule to this notice is hereby declared to be a periodic detention centre to be known as the Waipukurau Periodic Detention Centre.
- **4. Amendments**—(1) The Work Centres Notice 1984\* is hereby amended—
  - (a) By revoking subclause (6) of clause 2; and
  - (b) By revoking so much of the Schedule as relates to the land described as the Miller Street Work Centre.
  - (2) The Reporting Centres Notice (No. 2) 1988† is hereby amended—
  - (a) By revoking subclause (1) of clause 2; and
  - (b) By revoking the First Schedule.

# HASTINGS PERIODIC DETENTION CENTRE

First, all that parcel of land in the Hawke's Bay Land District containing 31.7 perches, more or less, situated in the City of Hastings, and being Lot 18 on Deposited Plan 9859, being part Heretaunga Block, and being all the land comprised and described in certificate of title, No. D3/1326, Hawke's Bay Registry; and

Secondly, all that parcel of land in the Hawke's Bay Land District containing 24 perches, more or less, situated in the City of Hastings, and being Lot 19 on Deposited Plan 9859, comprising portion of the Heretaunga Block, and being all the land comprised and described in certificate of title, No. E1/184, Hawke's Bay Registry.

Plan 8782, lodged in the office of the Chief Surveyor at Napier, and being also the land so described in *Gazette*, 1985, page 1089.
