NOTICE

1. Title and commencement—(1) This notice may be cited as the Periodic Detention Centre (Portage Road (New Lynn)) Notice 1998.

(2) This notice takes effect from 26 November 1998.

2. Portage Road (New Lynn) Periodic Detention Centre—The land described in the Schedule is a periodic detention centre to be known as the Portage Road (New Lynn) Periodic Detention Centre.

3. Revocations—The Work Centres Notice 1988* is amended by revoking clause 3 and the Second Schedule.

PORTAGE ROAD (NEW LYNN) PERIODIC DETENTION CENTRE

All that parcel of land in the North Auckland Land District containing 2580 square metres, more or less, being Lot 1 on Deposited Plan 65125 and being part Allotment 16 Parish of Waikomiti, and being all the land comprised and described in certificate of title No. 97B/249, North Auckland Land Registry; and

All that parcel of land in the North Auckland Land District containing 1517 square metres, more or less, being Lot 1 on Deposited Plan 86331 and being part of the bed of the Auckland Harbour, and being all the land comprised and described in certificate of title No. 44A/439, North Auckland Land Registry.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 26 November 1998, is made under the Criminal Justice Act 1985. It declares the land described in the Schedule to be a periodic detention centre, to be known as the Portage Road (New Lynn) Periodic Detention Centre.

The Centre is the same centre previously known as the New Lynn (Portage Road) Work Centre and deemed to be a periodic detention centre by section 47(6) of the Criminal Justice Amendment Act 1993. Parts of another notice that constituted the New Lynn (Portage Road) Work Centre are revoked by this notice.
