NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Periodic Detention Centre (Bledisloe Street (Kawerau)) Notice 1998.

(2) This notice takes effect from 26 November 1998.

**2. Bledisloe Street (Kawerau) Periodic Detention Centre**—The land described in the Schedule is a periodic detention centre to be known as the Bledisloe Street (Kawerau) Periodic Detention Centre.

**3. Revocation**—The Reporting Centre (Kawerau) Notice 1990\* is revoked.

## BLEDISLOE STREET (KAWERAU) PERIODIC DETENTION CENTRE

EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which takes effect from 26 November 1998, is made under the Criminal Justice Act 1985. It declares the land described in the Schedule to be a periodic detention centre, to be known as the Bledisloe Street (Kawerau) Periodic Detention Centre.

The Centre is the same centre previously known as a reporting centre for the Toroa Street Work Centre and deemed to be a periodic detention centre by section 47 (6) of the Criminal Justice Amendment Act 1993. The notice that constituted the reporting centre for use with the Toroa Street Work Centre is revoked by this notice.
