All that parcel of land in the South Auckland Land District containing 1012 square metres, more or less, situated in the Borough of Rotorua being Section 2 Block XXIX Town of Rotorua, and being all the land comprised and described in certificate of title Vol. 907, Folio 296 South Auckland Registry; and

All that parcel of land in the South Auckland Land District containing 612 square metres, more or less, being Lot 2 on Deposited Plan S.8560 and being part Section 3 Block XXIX Town of Rotorua, and being all the land comprised and described in certificate of title No. 3D/214, South Auckland Registry; and

All that parcel of land in the South Auckland Land District containing 400 square metres, more or less, being Lot 1 on Deposited Plan S.8560 and being part Section 3 Block XXIX Town of Rotorua, and being all the land comprised and described in certificate of title No. 6B/749, South Auckland Registry.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 16 August 2000, is made under the Criminal Justice Act 1985. It declares the land described in the Schedule to be a periodic detention centre to be known as the Haupapa Street (Rotorua) Periodic Detention Centre.

The Centre known as the Geddes Road (Rotorua) Periodic Detention Centre is to close when the Haupapa Street (Rotorua) Periodic Detention Centre becomes operational. The notice that constituted the Geddes Road (Rotorua) Periodic Detention Centre is revoked by this notice.
