NOTICE

1. Title and commencement—(1) This notice may be cited as the Periodic Detention Centre (David Street (Palmerston North)) Notice 1998.
 (2) This notice takes effect from 26 November 1998.

2. David Street (Palmerston North) Periodic Detention Centre—The land described in the Schedule is a periodic detention centre to be known as the David Street (Palmerston North) Periodic Detention Centre.

3. Revocations—The Work Centres Notice (No. 4) 1984* is amended by—

- (a) Revoking clause 2 (2); and
- (b) Revoking so much of the Schedule as relates to the land described as the David Street Work Centre.

DAVID STREET (PALMERSTON NORTH) PERIODIC DETENTION CENTRE

All that parcel of land in the Wellington Land District containing 405 square metres, more or less, situate in the City of Palmerston North, being Lot 35 on Deposited Plan 26, and being all the land comprised and described in certificate of title No. 42D/996, Wellington Registry; and

All that parcel of land in the Wellington Land District containing 405 square metres, more or less, situate in the City of Palmerston North, being Lot 36 on Deposited Plan 26, and being all the land comprised and described in certificate of title No. 42D/997, Wellington Registry.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 26 November 1998, is made under the Criminal Justice Act 1985. It declares the land described in the Schedule to be a periodic detention centre, to be known as the David Street (Palmerston North) Periodic Detention Centre.

The Centre is the same centre previously known as the David Street Work Centre and deemed to be a periodic detention centre by section 47(6) of the Criminal Justice Amendment Act 1993. Parts of another notice that constituted the David Street Work Centre are revoked by this notice.
