Pursuant to section 2 of the Criminal Justice Amendment Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Periodic Detention Order (No. 5) 1972.
 - (2) This order shall come into force on the 11th day of August 1972.
- 2. Rotorua—(1) Section 9 and sections 11 to 15 of the Criminal Justice Amendment Act 1962 shall apply with respect to male offenders who are of or over the age of 16 years and—
 - (a) Who are convicted after the commencement of this order by a Magistrate's Court at Rotorua; or
 - (b) Against whom a charge is proved after the commencement of this order in a Children's Court held at Rotorua.
- (2) Sections 10 to 15 of the said Act shall apply with respect to male offenders who are of or over the age of 16 years and in respect of whom a warrant of commitment may be issued after the commencement of this order by a Magistrate exercising jurisdiction in a Magistrate's Court held at Rotorua in respect of a fine imposed on or after the 15th day of July 1963.
