## ORDER IN COUNCIL

At Wellington this 24th day of June 1996

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 5 of the Public Finance Act 1989, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Public Finance (Transfers Between Outputs) Order 1996.
  - (2) This order shall come into force on the 28th day of June 1996.
- 2. Vote Defence Force—(1) It is hereby directed that the amounts specified in subclause (2) of this clause, being amounts appropriated in Vote Defence Force for the financial year ending on the 30th day of June 1996 for the classes of outputs in that Vote that are specified in

subclause (2) of this clause, be transferred, in the amounts specified in subclause (3) of this clause, to the classes of outputs in that Vote that are specified in subclause (3) of this clause.

(2) The classes of outputs from which, by subclause (1) of this clause, amounts are directed to be transferred and the amounts that, by that subclause, are directed to be transferred from each of those classes of outputs are as follows:

Vote Education—(1) It is hereby directed that the amounts specified in subclause (2) of this clause, being amounts appropriated in Vote Education for the financial year ending on the 30th day of June 1996 for the classes of outputs in that Vote that are specified in subclause (2) of this clause, be transferred, in the amounts specified in subclause (3) of this clause, to the classes of outputs in that Vote that are specified in subclause (3) of this clause.

- 4. Vote Health—(1) It is hereby directed that the amounts specified in subclause (2) of this clause, being amounts appropriated in Vote Health for the financial year ending on the 30th day of June 1996 for the classes of outputs in that Vote that are specified in subclause (2) of this clause, be transferred, in the amounts specified in subclause (3) of this clause, to the classes of outputs in that Vote that are specified in subclause (3) of this clause.
- (2) The classes of outputs from which, by subclause (1) of this clause, amounts are directed to be transferred and the amounts that, by that subclause, are directed to be transferred from each of those classes of outputs are as follows:

5. Vote Parliamentary Counsel—It is hereby directed that twenty-seven thousand dollars (\$27,000) of the amount appropriated in Vote Parliamentary Counsel for the financial year ending on the 30th day of June 1996 for the class of outputs called D2 Compilation of Reprinted

Legislation and of Tables and Indexes of Legislation be transferred to the class of outputs in that Vote called D3 Publication and Sale of Legislation.

- **6. Vote Police**—It is hereby directed that—
- (a) Three million eight hundred and twenty-five thousand dollars (\$3,825,000) of the amount appropriated in Vote Police for the financial year ending on the 30th day of June 1996 for the class of outputs called D3 Policing Services-Property Offences; and
- (b) Two million five hundred and fifty-two thousand dollars (\$2,552,000) of the amount appropriated in Vote Police for the financial year ending on the 30th day of June 1996 for the class of outputs called D4 Policing Services-Drugs and Anti-Social Offences,—

be transferred to the class of outputs in that Vote called D5 Policing Services-Traffic Offences.

- 7. Vote Revenue—(1) It is hereby directed that one million one hundred and twenty-five thousand dollars (\$1,125,000) of the amount appropriated in Vote Revenue for the financial year ending on the 30th day of June 1996 for the class of outputs called D7 Taxpayer Audit be transferred to the class of outputs in that Vote called D5 Revenue Assessment and Collection.
- (2) It is hereby directed that five hundred and sixty-three thousand dollars (\$563,000) of the amount appropriated in Vote Revenue for the financial year ending on the 30th day of June 1996 for the class of outputs called D7 Taxpayer Audit be transferred to the class of outputs in that Vote called D6 Management of Overdue Tax and Returns.
- **8. Revocation**—The Public Finance (Transfers Between Outputs) Order 1995\* is hereby revoked.

### EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 28 June 1996, is made under section 5 of the Public Finance Act 1989. That section authorises the Governor-General by Order in Council to direct that an amount appropriated in a Vote for a specified class of outputs be transferred to another class of outputs in that Vote where—

- (a) The amount transferred does not increase an appropriation for a financial year for a class of outputs by more than 5 percent; and
- (b) No other transfer under that section to that class of outputs has occurred during that financial year; and
- (c) The total amount appropriated for that financial year for all classes of outputs in that Vote is unaltered.

This order directs that-

- (a) A total of \$12,911,000 be transferred from the amounts appropriated for ten classes of outputs in Vote Defence Force for the financial year ending 30 June 1996 to seven other classes of outputs in that Vote;
- (b) A total of \$10,220,000 be transferred from the amounts appropriated for two classes of outputs in Vote Education for the financial year ending 30 June 1996 to three other classes of outputs in that Vote;
- (c) A total of \$1,000,000 be transferred from the amounts appropriated for five classes of outputs in Vote Health for the financial year ending 30 June 1996 to two other classes of outputs in that Vote;
- (d) The sum of \$27,000 be transferred from the amount appropriated for one class of outputs in Vote Parliamentary Counsel for the financial year ending 30 June 1996 to another class of outputs in that Vote;
- (e) A total of \$6,377,000 be transferred from the amounts appropriated for two classes of outputs in Vote Police for the financial year ending 30 June 1996 to another class of outputs in that Vote; and
- (f) The sum of \$1,688,000 be transferred from the amount appropriated for one class of outputs in Vote Revenue for the financial year ending 30 June 1996 to two other classes of outputs in that Vote.

An order, which is now spent, but which was made under section 5 of the Public Finance Act 1989 in respect of the financial year ending on 30 June 1995, is revoked.
