Order

1 Title

This order is the Public Finance (Transfers Between Outputs) Order 2006.

2 Commencement

This order comes into force on 30 June 2006.

10 Revocation

The Public Finance (Transfers Between Outputs) Order 2005 (SR 2005/178) is revoked.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 30 June 2006, is made under section 26A of the Public Finance Act 1989 (the **principal Act**).

Section 26A of the principal Act authorises the Governor-General, by Order in Council, to direct that an amount appropriated for an output expense appropriation in a Vote be transferred to another output expense appropriation in that Vote if—

- (a) the amount transferred does not increase that appropriation for a financial year by more than 5%; and
- (b) no other transfer under that section to that appropriation has occurred during that financial year; and
- (c) the total amount appropriated for that financial year for all output expense appropriations in that Vote is unaltered.

The principal Act was substantially amended by the Public Finance Amendment Act 2004 (the **amendment Act**) on 25 January 2005. Section 26A of the principal Act (as inserted by the amendment Act) replaced section 5 of the principal Act. The main difference between the 2 provisions is that section 26A provides for the transfer of resources between output expense appropriations, rather than between classes of outputs.

This order directs that—

 a total of \$85,000 is transferred from an amount appropriated for a category of output expenses in Vote Biosecurity for the financial year ending 30 June 2006 to 1 other category of output expenses in that Vote:

- a total of \$1,953,000 is transferred from the amounts appropriated for 4 categories of output expenses in Vote Corrections for the financial year ending 30 June 2006 to 6 other categories of output expenses in that Vote:
- a total of \$1,550,000 is transferred from the amounts appropriated for 7 categories of output expenses in Vote Defence Force for the financial year ending 30 June 2006 to 7 other categories of output expenses in that Vote:
- a total of \$4,642,000 is transferred from the amounts appropriated for 3 categories of output expenses in Vote Health for the financial year ending 30 June 2006 to 7 other categories of output expenses in that Vote:
- a total of \$300,000 is transferred from an amount appropriated for a category of output expenses in Vote National Library for the financial year ending 30 June 2006 to 2 other categories of output expenses in that Vote:
- a total of \$8,500,000 is transferred from the amounts appropriated for 2 categories of output expenses in Vote Revenue for the financial year ending 30 June 2006 to 4 other categories of output expenses in that Vote:
- a total of \$2,000,000 is transferred from an amount appropriated for a category of output expenses in Vote Social Development for the financial year ending 30 June 2006 to 1 other category of output expenses in that Vote.

An order, that is now spent, but that was made under section 5 of the principal Act (as temporarily continued in force as if it had not been amended by the amendment Act) in respect of the financial year ending on 30 June 2005, is revoked.
