THE POLICE FORCE REGULATIONS 1950, AMENDMENT NO. 9

ORDER IN COUNCIL

At the Government Buildings at Wellington this 31st day of March 1958

Present:

THE HON. C. F. SKINNER, M.C., PRESIDING IN COUNCIL

PURSUANT to the Police Force Act 1947, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Police Force Regulations 1950, Amendment No. 9, and shall be read together with and deemed part of the Police Force Regulations 1950* (hereinafter referred to as the principal regulations).

2. The principal regulations are hereby amended by inserting, after regulation 109, the following regulation:

"109A. (1) For the purpose of determining the seniority of any member of the Force who, during the Second World War and while on leave of absence from the Force served outside New Zealand in any branch of the naval, military, or air forces of New Zealand, and who, within two years after his return to duty in the Force, passed any examination qualifying him for promotion, the following provisions shall apply:

"(a) Between the date of the commencement of his leave of absence and the date of the commencement of this regulation he shall be deemed to have been promoted to such rank and at such time as the Promotion Board considers he would have been promoted if he had remained on duty with the Force during the period when he was on leave of absence and had passed the qualifying examination aforesaid at the commencement of that period:

"(b) Any person deemed to have been promoted in accordance with paragraph (a) of this subclause who, before the commencement of this regulation, has passed a subsequent examination qualifying him for further promotion shall be deemed to have been further promoted to such rank and at such time as the Promotion Board considers he would have been promoted having regard to his order of seniority determined in accordance with the said paragraph (a).

"(2) The provisions of subclause (1) of this regulation shall relate only to seniority and no person shall be entitled to any additional pay by reason of his having been deemed to be promoted under that subclause:

"Provided that any person to whom that subclause applies shall, if he is appointed to any rank after the commencement of this regulation, be deemed for all purposes at the date of his appointment to have the same number of years of service in the rank to which he is so appointed as he would have if he had been appointed to that rank on the date on which he is deemed to have been promoted to that rank under the said subclause (1)."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide that any member of the Force who served out of New Zealand during the Second World War while on leave of absence from the Force and who passed a qualifying examination within two years after returning to duty shall, for the purposes of determining seniority, be deemed to have been promoted to such rank and at such time as the Promotion Board considers he would have been promoted if he had remained in the Force and had passed the examination at the commencement of his leave of absence.

If a subsequent qualifying examination is passed before the commencement of the regulations, his seniority, determined as aforesaid, will be taken into consideration for the purposes of subsequent promotion.
