THE PRICE FREEZE REGULATIONS 1974, AMENDMENT NO. 2

ORDER IN COUNCIL

At the Government House at Wellington this 17th day of February 1975

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Price Freeze Regulations 1974, Amendment No. 2, and shall be read together with and deemed part of the Price Freeze Regulations 1974* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Interpretation—Regulation 2 of the principal regulations is hereby amended by adding, as subclause (2), the following subclause:

“(2) For the purposes of these regulations, the publication or exhibition of a price list in respect of any fish or the furnishing of a quotation for any fish, or the exposure of any fish with a specification or an indication of the price thereof attached thereto or displayed in the vicinity thereof or in connection therewith, shall be deemed to constitute an offer to sell that fish at the price so specified or indicated.”

3. First and Second Schedules substituted—The principal regulations are hereby amended by revoking the First and Second Schedules (as substituted by regulation 2 of the Price Freeze Regulations 1974, Amendment No. 1), and substituting the First and Second Schedules set out in the Schedule to these regulations.

"FIRST SCHEDULE

Part I

DESCRIPTION OF DISTRICTS

1. The Northland District—

The city of Whangarei, the boroughs of Dargaville, Kaitaia, and Kaikohe, the counties of Bay of Islands, Hobson, Hokianga, Kaikohe, Kaitaia, Mangonui, Otamatea, Whangarei, and Whangaroa, the independent town district of Hikurangi, and the community of Kawakawa.

2. The Auckland District—

The cities of Auckland, Manukau, Papatoetoe, Takapuna, and Waitemata, the boroughs of Birkenhead, Devonport, East Coast Bays, Ellerslie, Glen Eden, Henderson, Heienville, Howick, Mount Albert, Mount Eden, Mount Roskill, Mount Wellington, New Lynn, Newmarket, Northcote, Onehunga, One Tree Hill, Otahuhu, Papakura, Pukekohe, Tuakau, and Waiuku, and the counties of Franklin and Rodney.

3. The Tauranga District—

The city of Tauranga and the boroughs of Mount Maunganui, Murupara, Kawerau, Te Puke, and Whakatane, and Tauranga County.

4. The Coromandel/Thames District—

The boroughs of Paeroa, Thames, and Waihi and the counties of Coromandel and Thames.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations make the following amendments to the principal regulations:

- (a) Regulation 2 provides that the publication or posting of a price list or the furnishing of a quote for fish constitutes an offer for sale.
- (b) Regulation 3 substitutes new maximum wholesale and retail prices for fish sold in the districts defined in the First and Second Schedules.
