PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Price Freeze Regulations 1974, Amendment No. 3, and shall be read together with and deemed part of the Price Freeze Regulations 1974* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. First and Second Schedules substituted—(1) The principal regulations are hereby amended by revoking the First and Second Schedules (as substituted by regulation 3 of the Price Freeze Regulations 1974, Amendment No. 2), and substituting the First and Second Schedules set out in the Schedule to these regulations.

(2) Regulation 3 of, and the Schedule to, the Price Freeze Regulations 1974, Amendment No. 2, are hereby consequentially revoked.

DESCRIPTION OF DISTRICTS

1. The Northland District—
The city of Whangarei, the boroughs of Dargaville, Kaitaia, and Kaikohe, the counties of Bay of Islands, Hobson, Hokianga, Kaikohe, Kaitaia, Mangonui, Otamatea, Whangarei, and Whangaroa, the independent town district of Hikurangi, and the community of Kawakawa.
2. The Auckland District—
The cities of Auckland, Manukau, Papatoetoe, Takapuna, and Waitemata, the boroughs of Birkenhead, Devonport, East Coast Bays, Ellerslie, Glen Eden, Henderson, Helensville, Howick, Mount Albert, Mount Eden, Mount Roskill, Mount Wellington, New Lynn, Newmarket, Northcote, Onehunga, One Tree Hill, Otahuhu, Papakura, Pukekohe, Tuakau, and Waiuku, and the counties of Franklin and Rodney.
3. The Tauranga District—
The city of Tauranga and the boroughs of Mount Maunganui, Murupara, Kawerau, Te Puke, and Whakatane, and Tauranga County.
4. The Coromandel/Thames District—
The boroughs of Paeroa, Thames, and Waihi and the counties of Coromandel and Thames.

EXPLANATORY NOTE

These regulations replace the First and Second Schedules to the principal regulations. The maximum prices for fish sold in the Northland, Auckland, Tauranga, Coromandel/Thames, Waikato, Rotorua, and King Country Districts (as defined in the Schedules) are generally increased.
