

# THE PRICE FREEZE REGULATIONS 1982, AMENDMENT NO. 10

### ORDER IN COUNCIL

At the Government House at Wellington this 19th day of December 1983

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title—These regulations may be cited as the Price Freeze Regulations 1982, Amendment No. 10, and shall be read together with and deemed part of the Price Freeze Regulations 1982\* (hereinafter referred to as the principal regulations).
- **2. Commencement and expiry**—(1) These regulations shall come into force on the 20th day of December 1983.
- (2) These regulations shall continue in force until the close of the 29th day of February 1984, and shall then expire.
- **3. Exemptions**—Regulation 12 of the principal regulations is hereby amended by inserting, after subclause (5B) (as inserted by regulation 12 (2) of the Price Freeze Regulations 1982, Amendment No. 7), the following subclause:

"(5c) Nothing in these regulations (other than regulation 13) applies with respect to—

(a) Any agreement to dispose of goods for valuable consideration after the 29th day of February 1984:

"(b) Any offer to dispose of goods for valuable consideration after the 29th day of February 1984:

"(c) The publication or exhibition of a price list in respect of any goods or services, being goods to be sold or services to be supplied only after the 29th day of February 1984:

"(d) The furnishing of a quotation for any goods or services, being goods to be sold or services to be supplied only after the 29th day of February 1984."

4. Exemption in respect of certain residential accommodation for the aged, infirm, and needy and for victims of domestic violence—Regulation 12A of the principal regulations (as inserted by regulation 3 of the Price Freeze Regulations 1982, Amendment No. 2) is hereby amended by adding to paragraph (b) the words "or for victims of domestic violence".

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 20 December 1983, amend the Price Freeze Regulations 1982.

Regulation 3 provides that certain transactions and activities which take place during the period of the price freeze but which relate to the disposal of goods or the supply of services after 29 February 1984 will not contravene the principal regulations.

Regulation 4 enables the Minister of Trade and Industry, by notice in the Gazette, to exempt from the principal regulations services or any class of services consisting of the provision by any charitable or religious organisation or any body corporate (not being a company within the meaning of the Companies Act 1955) of residential accommodation for victims of domestic violence.
