

THE PRICE FREEZE REGULATIONS 1984, AMENDMENT NO. 2

ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of October 1984

Present:

THE RIGHT HON. DAVID LANGE PRESIDING IN COUNCIL PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title—These regulations may be cited as the Price Freeze Regulations 1984, Amendment No. 2, and shall be read together with and deemed part of the Price Freeze Regulations 1984* (hereinafter referred to as the principal regulations).

2. Commencement and expiry—(1) These regulations shall come into force on the 9th day of October 1984.

(2) These regulations shall continue in force until the close of the 8th

day of November 1984, and shall then expire.

- **3. Expiry of principal regulations**—(1) Regulation 2 (2) of the principal regulations is hereby amended by omitting the words "18th day of October 1984", and substituting the words "8th day of November 1984".
- (2) Regulation 2 (2) of the Price Freeze Regulations 1984, Amendment No. 1 is hereby consequentially amended by omitting the words "18th day of October 1984", and substituting the words "8th day of November 1984".
- **4. Notification of increases in prices**—Regulation 8 (2) of the principal regulations is hereby consequentially amended by omitting the words "18th day of October 1984", and substituting the words "8th day of November 1984".
- **5. Exemptions**—Regulation 17 of the principal regulations is hereby amended by inserting, after subclause (7), the following subclause:

"(7A) Nothing in these regulations (other than regulation 19) applies with

respect to-

- d'(a) Any agreement to dispose of goods for valuable consideration after the 8th day of November 1984:
- "(b) Any offer to dispose of goods for valuable consideration after the 8th day of November 1984:
- "(c) The publication or exhibition of a price list in respect of any goods or services, being goods to be sold or services to be supplied only after the 8th day of November 1984:
- "(d) The furnishing of a quotation for any goods or services, being goods to be sold or services to be supplied only after the 8th day of November 1984."
- 6. Restrictions on effective date of authorised price increases—Regulation 23 of the principal regulations is hereby consequentially amended by omitting from subclause (2), and also from subclause (3), the words "18th day of October 1984", and substituting in each case the words "8th day of November 1984".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations continue the Price Freeze Regulations 1984 in force until the close of 8 November 1984. Those regulations were to have expired with the close of 18 October 1984.

Regulation 5 provides that certain transactions and activities which take place during the period of the price freeze but which relate to the disposal of goods or the supply of services after 8 November 1984 will not contravene the principal regulations.
