ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Plumbers, Gasfitters, and Drainlayers Act 1976, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Plumbers, Gasfitters, and Drainlayers Regulations 1977, Amendment No. 3, and shall be read together with and deemed part of the Plumbers, Gasfitters, and Drainlayers Regulations 1977\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

**2. Fees**—The principal regulations are hereby amended by revoking regulation 11, and substituting the following regulation:

“11. The fees payable under the Act shall be those set out in the Eighth Schedule to these regulations.”

**3. New scale of fees substituted**—The principal regulations are hereby amended by revoking the Eighth Schedule, and substituting the Eighth Schedule set out in the Schedule to these regulations.
