THE PLUMBERS, GASFITTERS, AND DRAINLAYERS REGULATIONS 1977, AMENDMENT NO. 6

ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Plumbers, Gasfitters, and Drainlayers Act 1976, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Plumbers, Gasfitters, and Drainlayers Regulations 1977, Amendment No. 6, and shall be read together with and deemed part of the Plumbers, Gasfitters, and Drainlayers Regulations 1977* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1996.

2. Exemptions—Regulation 10A of the principal regulations (as substituted by regulation 2 of the Plumbers, Gasfitters, and Drainlayers Regulations 1977, Amendment No. 5) is hereby amended by inserting, after subclause (1), the following subclause:

*S.R. 1977/67 Amendment No. 1: S.R. 1982/81 Amendment No. 2: S.R. 1985/234 Amendment No. 3: (*Revoked by S.R. 1993/74*) Amendment No. 4: S.R. 1993/74 Amendment No. 5: S.R. 1994/27 "(1A) A fee shall be payable by a person who wishes to satisfy the Board, pursuant to section 56A of the Act, that he or she is competent to install and maintain particular sanitary plumbing equipment or sanitary plumbing equipment of a particular kind."

3. New scale of fees substituted—The principal regulations are hereby amended by revoking the Eighth Schedule (as substituted by regulation 3 (1) of the Plumbers, Gasfitters, and Drainlayers Regulations 1977, Amendment No. 5), and substituting the Eighth Schedule set out in the Schedule to these regulations.

4. Revocation—Regulation 3 of, and the Schedule to, the Plumbers, Gasfitters, and Drainlayers Regulations 1977, Amendment No. 5 are hereby consequentially revoked.

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1996, prescribe a new scale of fees payable under the Plumbers, Gasfitters and Drainlayers Act 1976.

Various increases and reductions have been made in respect of existing fees. In addition, new fees for additional combinations of types of licence, and a new fee for an application for an exemption under section 56A of the Act, have been included.

The fees prescribed are inclusive of goods and services tax.
