



**THE PENAL INSTITUTIONS (TONGARIRO AND RANGIPO)  
NOTICE 1994**

PURSUANT to section 4 of the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

---

**NOTICE**

**1. Title and commencement**—(1) This notice may be cited as the Penal Institutions (Tongariro and Rangipo) Notice 1994.

(2) This notice shall take effect from the 28th day of August 1994.

**2. Tongariro Prison**—The land described in the First Schedule to this notice is hereby declared to be—

(a) A prison; and

(b) A corrective training institution,—  
to be known as Tongariro Prison.

**3. Rangipo Prison**—The land described in the Second Schedule to this notice is hereby declared to be—

(a) A prison; and

(b) A corrective training institution,—  
to be known as Rangipo Prison.

**4. Revocations**—(1) The notices specified in the Third Schedule to this notice are hereby revoked.

(2) The Penal Institutions Notice 1974\* is hereby consequentially amended by revoking clause 5 and the Third Schedule.

(3) The Penal Institutions Notice (No. 2) 1981† is hereby consequentially amended by revoking clauses 5 and 7 and the Fourth and Sixth Schedules.

(4) The Penal Institutions Notice (No. 3) 1981‡ is hereby consequentially amended by revoking clause 3 and the First and Second Schedules.
