ORDER IN COUNCIL

At Wellington this 29th day of June 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 71 of the Private Investigators and Security Guards Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

---

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Private Investigators and Security Guards Regulations 1975, Amendment No. 3, and shall be read together with and deemed part of the Private Investigators and Security Guards Regulations 1975\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

**2. New scale of fees substituted**—The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 of the Private Investigators and Security Guards Regulations 1975,

Amendment No. 2), and substituting the Second Schedule set out in the Schedule to these regulations.

**3. Refund of fees paid in excess of amount now prescribed**—If any person has, in respect of the year commencing with the 1st day of April 1987, paid any fee in excess of \$45 on application for the grant or renewal of a certificate of approval, that person shall be entitled to a refund of the amount by which the fee paid exceeded the sum of \$45.

**4. Revocation**—The Private Investigators and Security Guards Regulations 1975, Amendment No. 2 are hereby revoked.

### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations prescribe a new scale of fees in substitution for that prescribed earlier this year. That earlier scale prescribed the same fee for the grant and for the renewal of certificates of approval as the fee for the grant and for the renewal of a licence.

This substituted scale prescribes substantially lower fees for certificates of approval, and provision is made for a refund where the higher fee has already been paid.
